INTERGOVERNMENTAL COOPERATION AGREEMENT BETWEEN THE HARLEM SCHOOL DISTRICT NO. 122 AND THE CITY OF LOVES PARK FOR THE ASSIGNMENT OF A SCHOOL RESOURCE OFFICER AT THE HARLEM MIDDLE SCHOOL DURING THE 2013-2014 AND 2014-2015 SCHOOL YEARS.

WHEREAS, the Harlem School District No. 122 ("District") educates approximately 1,200 students at the Harlem Middle School, 735 Windsor Road, Loves Park, Winnebago County, Illinois; and

WHEREAS, the Board of Education of the Harlem School District No. 122 desires to provide general police protection and law enforcement services at the Harlem Middle School during the 2013-2014 and 2014-2015 school years; and

WHEREAS, the Board of Education of the Harlem School District No. 122 believe that it would be in the best interest of the students at the Harlem Middle School if a member of the City of Loves Park Police Department was assigned as a School Resource Officer at the Harlem Middle School during the 2013-2014 and 2014-2015 school years; and

WHEREAS, the City of Loves Park ("City") is willing to assist the Harlem School District No. 122 with the provision of general police protection and law enforcement services at the Harlem Middle School during the 2013-2014 and 2014-2015 school years; and

WHEREAS, pursuant to Article VII, Section 10 of the Constitution of the State of Illinois, and 5 ILCS 220/1 et seq., units of local government and school districts may contract to obtain or share services and to otherwise share powers, privileges, and authority with one another; and

WHEREAS, the City Council of the City of Loves Park has authorized its Mayor to execute this Intergovernmental Agreement ("Agreement") on behalf of the City; and

WHEREAS, the Harlem Board of Education has authorized the Superintendent of the District to execute this Agreement on behalf of the District. Page two.

NOW, THEREFORE, in consideration of the mutual promised and covenants provided here, it is hereby agreed by and between the City and the District as follows:

- 1) The City and the District shall mutually agree to the assignment of a City of Loves Park Police Officer who is qualified as a Certified School Resource Officer to be the School Resource Officer at the Harlem Middle School for the 2013-2014 and 2014-2015 school years. The individual assigned to this position shall be an employee of the City whose work days and hours shall be governed by the needs of the District.
- 2) The School Resource Officer shall be subject to the rules and policies of the District while performing his/her duties.
- 3) The City shall be responsible for equipping the School Resource Officer with a police uniform, police gear and an automobile, and for the costs associated with replacing and/or maintaining those items (i.e., gasoline, automobile tune-ups).
- 4) The salary and benefits to be paid to the School Resource Officer shall be established by the collective bargaining agreement between the City and the Union representing the School Resource Officer. The District agrees to pay seventy percent (75%) of the cost of the School Resource Officer's salary and benefits for the 2013-2014 and 2014-2015 school years. The amount to be paid by the district shall be divided equally amoung the months of the school year in which the School Resource Officer is assigned to work at the Harlem Middle School. The City shall bill the District on a monthly basis for this expense. The District agrees to remit payment within forty-five (45) days after receipt of the monthly invoice.
- 5) This Agreement may be terminated by either party upon written notice of a termination date provided to the other party at least sixty days prior to such termination.
