Subject:	IX. ACTION ITEMS B. Consider Approving 2024 Bond Program – Guaranteed Maximum Price (GMP) for Plummer Elementary, Waterford Oaks Elementary, and Lacy Enrollment Center Phase 2

Summary:	<p>In May 2024, Cedar Hill ISD voters approved two bond referendums totaling \$282.4 million to fund capital improvements, the purchase of new buses, and district-wide technology enhancements.</p> <p>Plummer Elementary, Waterford Oaks Elementary and Lacy Enrollment Center – Phase 2 are three of the projects included in the 2024 Bond Program. Design for all three renovation projects has been completed by Huckabee & Associates. Following design completion, CORE Construction solicited competitive bids from trade contractors, evaluated proposals, and submitted Guaranteed Maximum Price (GMP) proposals to the Bond Program Team.</p> <p>The GMP for Plummer Elementary in the amount of \$9,085,444 was presented to the Facilities Committee on January 22, 2026. Scope of work includes:</p> <ul style="list-style-type: none">• Safety and security upgrades: secure vestibule with access control, campus-wide cameras, new public address system, bells and clocks, and safety glazing film• Roof and HVAC upgrades (2001 addition only); installation of fire sprinklers				

- Interior improvements for new Biomedical Science classrooms; stage lighting and sound upgrades; restroom renovations; ceiling tile repairs; painting; new cabinetry
- Furniture and equipment

Construction for **Plummer Elementary** is scheduled to begin in June 2026 with an anticipated construction completed in August 2027.

The GMP for **Waterford Oaks Elementary** in the amount of \$12,152,145 was presented to the Facilities Committee on January 22, 2026. Scope of work includes:

- Safety and security upgrades: secure vestibule with access control, campus-wide cameras, new public address system, bells and clocks, and safety glazing film
- Roof and HVAC upgrades; exterior improvements; installation of fire sprinklers
- Interior renovations including restrooms, library, flooring, ceiling tile repairs, painting, new cabinetry, and stage lighting and sound upgrades
- Furniture and equipment

Construction for **Waterford Oaks Elementary** is scheduled to begin in June 2026 with an anticipated construction completed in June 2027.

The GMP for **Lacy Enrollment Center - Phase 2** in the amount of \$2,470,260 was presented to the Facilities Committee on January 22, 2026. Scope of work includes:

- Safety and security upgrades: secure vestibule with access control, campus-wide cameras, and safety glazing film
- Interior renovations including restrooms

Construction for **Lacy Enrollment – Phase 2** is scheduled to begin in June 2026 with an anticipated construction completed in June 2027.
