The attached reports show the activity for the quarter ended May 31, 2010.

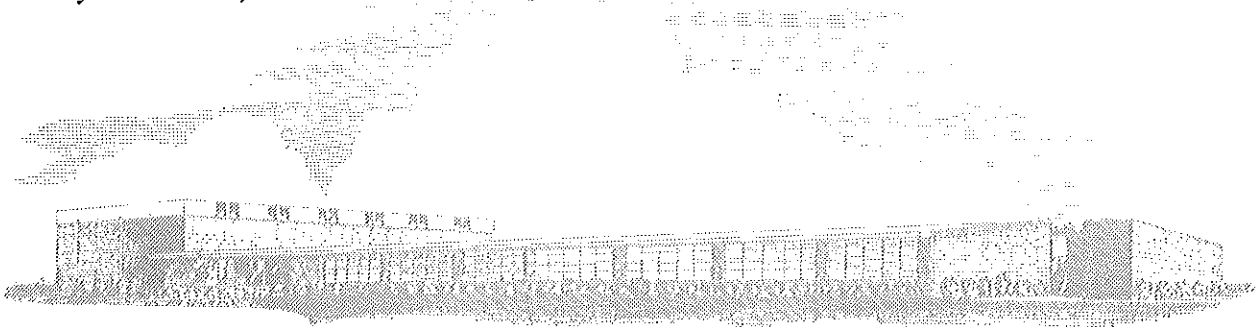
