ALLOWANCE AND CONTINGENCIES

The following allowances and contingencies are included in this proposal:

1 Sod and Irrigation \$ 30,000

GENERAL

- 1. This GMP represents the bid document for package one with the understanding that not all trades related to complete the overall project is included in the documents or included in the GMP. The GMP represents getting the softball field turf ordered before the remaining package two goes out to bid.
- 2. Soil stabilization is scarify and recompact 6" of soil and 6" of drainage rock.
- 3. Site grading, laser grading, utilities, drainage rock, and turf are included.
- 4. An allowance is included for capping irrigation lines, sod replacement, and possible rework of irrigation lines.
- 5. Bullpen turf is excluded.
- 6. Paving elastic layer is excluded.
