III. ACTION ITEMS

A. Policy 6146 – Graduation Requirements

Dr. Craw and Dr. Woleck spoke about the three areas that will be updated in this policy, due to legislative changes that need to be put in place. They were also able to remove parts that were irrelevant, for example, the years in the policy had passed. One language change is "Vision of a Learner." Students need to take the personal finance class and can have a choice as to where they will apply it. It is one half credit. Kris and James will work together to discuss and possibly change the SEE project.

B. New Fairfield High School Parking Guidelines

Mr. D'Amico spoke about unregistered vehicles being on campus, such as out of state plates. Parking is offered per semester. Students must upload a picture of their CT license, as well as their CT registration. A draft for an updated version was presented.

C. Policy3517.1 - Identification Badges

Dr. Craw mentioned our discussion last spring in regard to students wearing ID badges. Questions were brought to Ken's attention about the practice at the HS matching what our policy actually says. They have been required to have them on them and be able to display them when asked. There was some discussion about whether or not the high school students should be required to wear them or not. This committee will not take any action on this policy tonight. The policy will remain the same as previously written.

D. Policy 2400 - Evaluation of the Superintendent

Samantha worked with Dr. Craw and Gail DeFeo to update this policy. The instructions stayed the same besides the current date/year. Samantha shared information about the updated evaluation form. Section C - changed some wording, specified safe and secure, took out an item that was not the Superintendent's role. Section D - reworded relationship with other boards in town, the Superintendent will make sure budget is responsibly managed....E - added E10, residency, F - relationship with the board, the Supt does not always need to provide the board information about every ongoing case, or can't always provide information for legal reasons...The annual district

goals will change every year. An adjustment will be made to some of the bullets. The evaluation summary has stayed the same.

2400 - Evaluation; a change will be made and put in place that BOE members may only participate in person to evaluate the Superintendent at the annual evaluation meeting.
