## **BOARD MEETING**

The regular meeting of the Board of Trustees of the Aledo Independent School District was held on Monday, February 20, 2012, beginning at 7:00 P.M. in the Aledo I.S.D. Board Room with the following members present: Vice President Jay Stringer, Secretary Johnny Campbell, Bobby Rigues, Steve Bartley, and Hoyt Harris. Dinner was provided at 6:15 P.M. for the Board.

### **AGENDA**

Vice President Jay Stringer called the meeting to order at 7:00 P.M.

Vice President Jay Stringer determined a quorum was present at this time.

Four students, representing Daniel Ninth Grade Campus and the Leading Ladies organization, led everyone in the pledges of allegiance to the United States and Texas flags.

- ~ District Events Several activities were presented as informational items and Board opportunities. The next board meeting is scheduled for Monday, March 19, 2012, at 7:00 P.M.
- ~ Update on Equity Center Lawsuit The lawsuit has been assigned to Judge John Dietz. Over fifty percent of school districts in the state have joined a lawsuit.
- ~ May Trustee Election Update There have been four who have filed for the Trustee election on May 12, 2012: Place 1 Jay Stringer, Place 2 Johnny Campbell, Place 3 Gary Aguillard, Tricia Haber.
  - ~ Bring Your Own Device The pilot program will only be used at High School, beginning March 26.

- ~ Certificate of Compliance with Children's Internet Protection Act Kathy Allen, Executive Director of Curriculum, presented updated information to the Board. Being compliant is a pre-requisite to receiving universal service discount rates (E-Rates).
- ~ STAAR / EOC Report Kathy Allen, Executive Director of Curriculum, presented an update on the 15% rule, pending the Final Commissioner's Rule at the end of February.
- ~ CRE Report Child Nutrition Earl Husfeld, CFO reported that Aledo I.S.D. received an EXCELLENT rating at the conclusion of the CRE (Coordinated Review Effort).
- ~ Potential Refinancing of Outstanding Bonds Earl Husfeld, CFO, reported that he will bring information to the March meeting.
- ~ Texas NCLB School Report Card Mrs. Denise Dugger, Executive Director of Professional Development and Accountability, reported that the Texas NCLB School Report Card will be sent out March 1, 2012.
