

**Police/School Liaison Interlocal Agreement**  
**City of Oak Point and Denton ISD**  
**(September 11, 2018)**

**SUMMARY:**

This item requests approval of Police/School Liaison Interlocal Agreement between the City of Oak Point and the Denton Independent School District whereas the City shall provide Denton ISD with one (1) certified police officer to serve as a school resource officer (SRO) assigned to Dr. Rudy and Rosemary Rodriguez Middle School and shall, as time permits, also perform service at Cross Oaks Elementary School.

**PREVIOUS BOARD ACTION:**

The Denton ISD Board of Trustees have approved similar agreements with the City of Denton, Denton County Sheriff's Department, Town of Little Elm, and the City of Corinth to provide SROs to our campuses in their jurisdiction.

**BACKGROUND INFORMATION:**

- The opening of Rudy and Rosemary Rodriguez Middle School requires the addition of an SRO.
- The physical location of Rodriguez Middle School within the City of Oak Point initiated Denton ISD to pursue this interlocal agreement.

**SIGNIFICANT ISSUES:**

- The addition of Rodriguez Middle School necessitated the need to pursue an agreement with the City of Oak Point to provide a SRO. Rodriguez Middle and Cross Oaks Elementary are under the police jurisdiction of the Oak Point Police Department.

**FISCAL IMPLICATIONS:**

- For school year 2018-19, cost will be \$69,634
- Quarterly Payment Amounts: \$17,408 (July and October of 2018 and January and April 2019)
- Costs will be borne by: DISD will be responsible for 75% of SROs' salary and leasing of police vehicle.

DISD	75% =	\$57,785 (salary for one officer)
Supplies		\$ 5,225
Police Vehicle		<u>\$ 6,624</u> (cost for lease of police vehicle)
Total cost:		\$69,634
