**Teacher Housing Presentation**: The Odessa Housing Finance Corporation (OHFC) Executive Director Jill Miller and The NRP Group, Inc. Vice President of Governmental Affairs Debra Guerrero presented a prospect of offering housing to teachers hired from outside of Odessa. Medical Center Health Systems and Texas Tech University Health Science Center have entered into a partnership to build a four story 234 unit apartment complex in downtown Odessa with OHFC. The partnership offered ECISD the opportunity to join this endeavor. For a \$3.25 million dollar investment ECISD would be given a minimum of 75 units for new teachers and would receive 10% interest rate.
