**AGENDA ITEM:** Discussion of Lexia Core5 Reading & Lexia PowerUp Literacy Purchase

**PRESENTER:** Earl Husfeld, Chief Financial Officer

### **BACKGROUND INFORMATION:**

- Per Board Policy CH (Local), any single, budgeted purchase of goods or services that costs \$50,000 or more, regardless of whether the goods or services are competitively purchased, shall require Board approval before a transaction may take place.
- During the 2019-2020 school year, the District would like to broadly implement Lexia in grades K-8 to develop students' critical reading skills through individualized learning pathways.
- Lexia's Core5 Reading is an adaptive literacy program that the District will use to support students in grades K-5 that provides targeted instruction in six areas of reading: phonological awareness, phonics, structural analysis, automaticity/fluency, vocabulary, and comprehension.
- Lexia's PowerUp Literacy is designed to support students in grades 6-12 and allows students to progress independently to higher levels of more complex content based on skill mastery. PowerUp also provides a multi-tiered system of intervention that closes gaps for non-proficient readers while accelerating literacy gains for students working on grade level material. Content is organized into three integrated strands: word study, grammar, and comprehension. In Aledo ISD, PowerUp will be widely used in grades 6-8, and, in grades 9-12, will predominantly be used to support students reading below grade level.
- Lexia's embedded assessment system collects student data from the online program and provides ongoing progress monitoring for all students without a shutdown test event. Lexia also provides teachers with resources to provide direct instruction for intervention based on individual student needs.
- Lexia provides ongoing, real-time performance data to drive instructional priorities. Teachers can provide differentiated instruction based on the data-driven action plan that prescribes the instructional intensity necessary to help students reach their individual goals.
- The cost associated with purchasing Lexia for the 2019-2020 school year is as follows:
  - Lexia Core5 Reading 1 Year Unlimited Site License Bundle for 5 Elementary Campuses - \$72,000.00
  - Lexia PowerUp Literacy 1 Year Unlimited Site License Bundle for McAnally Intermediate, Aledo Middle School, and Aledo High School - \$40,700.00
  - Multi-Site Incentive – Credit of \$800.00
  - Total Price - \$111,900.00

- The majority of the cost of these Lexia items will be funded from the planned non-renewal of MAP with an annual cost of \$63,212.50 and the planned non-renewal of iStation with an annual cost of \$43,340.00.
- This item will be presented to the Board of Trustees for consideration and possible action at the August regular board meeting.

**FISCAL INFORMATION:**

Cost of \$111,900.00 will be paid from Instructional Materials Allotment, Fund 410.
