Interlocal Cooperation Agreement for School Resource Investigator (Officer) Denton County (County) and Denton Independent School District

(August 22, 2023)

SUMMARY:

- This item requests approval of Interlocal Cooperation Agreement for a School Resource Investigator between the County and the District whereas the County provides Denton ISD with one (1) certified police officer to serve as school resource officer (SRO) assigned to Harpool Middle School and supporting Adkins, E.P. Razor, and Blanton Elementary schools.

PREVIOUS BOARD ACTION:

- The Denton ISD Board of Trustees have approved similar agreements with the City of Denton, Town of Little Elm, City of Corinth, and City of Oak Point to provide SROs to our campuses in their jurisdiction.

BACKGROUND INFORMATION:

- This is a continuation of service provided by the County to assist our Lantana schools with a School Resource Officer.

SIGNIFICANT ISSUES:

-The location of Harpool Middle School and our elementary schools in the Lantana area necessitated the need to pursue an agreement with the Denton County Sheriff's Department to provide an SRO. These schools are not under the jurisdiction of a specific city or township.

FISCAL IMPLICATIONS:

For school year 2023-24, cost will be \$122,287

- Monthly Payment Amounts: \$10,191(October 1 of 2023 through September 30, 2024)

- Costs will be borne by: DISD will be responsible for 100% of SRO's salary and rental cost of police vehicle.
