Talking points from the June 23, 2021 meeting:</p> <p><b>Information Items</b></p> <ul style="list-style-type: none"> <li>5RO - K-6 and 7-12 videos will be released and sent out this week. The 7-12 Registration Handbook is live on the 5RO website. Information is being shared on all local radio and television channels.</li> <li>GCED has returned to offering a <a href="#">Summer Symposium</a>. This week of training is designed to provide training needed across our member districts. Any staff in the county can attend. GCED covers training costs. Each year we have staff turnover. This week of training gives us a chance to bring new staff up to date on current practices in our districts. Trainings this summer include: A.I.M., Zones of Regulation, Check &amp; Connect, FAST Manager Training, FAST SAEBRS System, Sonday I and II, Educlimber Introduction, Read 180, System 44, Math 180, Springboard Math, Assistive Technology, Behavior Team 101 and Progress Monitoring.</li> <li>During 2020-2021, GCED piloted Safe and Sound Protocol in the member districts. The SSP's effectiveness has been proven in a wide range of studies, most notably in two clinical trials involving children with Autism Spectrum Disorder. Trial participants demonstrated statistically significant improvements in: Emotional control, Behavioral organization and Hearing sensitivity and listening. We are expanding this strategy for use by all of our occupational therapists beginning the 2021-22 school year.</li> <li>Projections show that we have met MOE for the 2020-21 school year. This was a concern with changes in assignments due to COVID-19.</li> <li>GCED will conduct its Strategic Planning on July 12, 2021. Bruce Miles will be facilitating.</li> </ul> <p><b>Action Items</b></p> <ul style="list-style-type: none"> <li>The Board approved the 2nd Reading of various policy additions and revisions.</li> <li>GCED and GCHHS Contracts. Cherie completed negotiations with GCHHS. This collaboration has been in place since 1990 when the local school district boards of Cannon Falls, Goodhue,</li> </ul>
