Change in Clackamas Budgeted Employee FTE by Position Type, 2016 - 2025

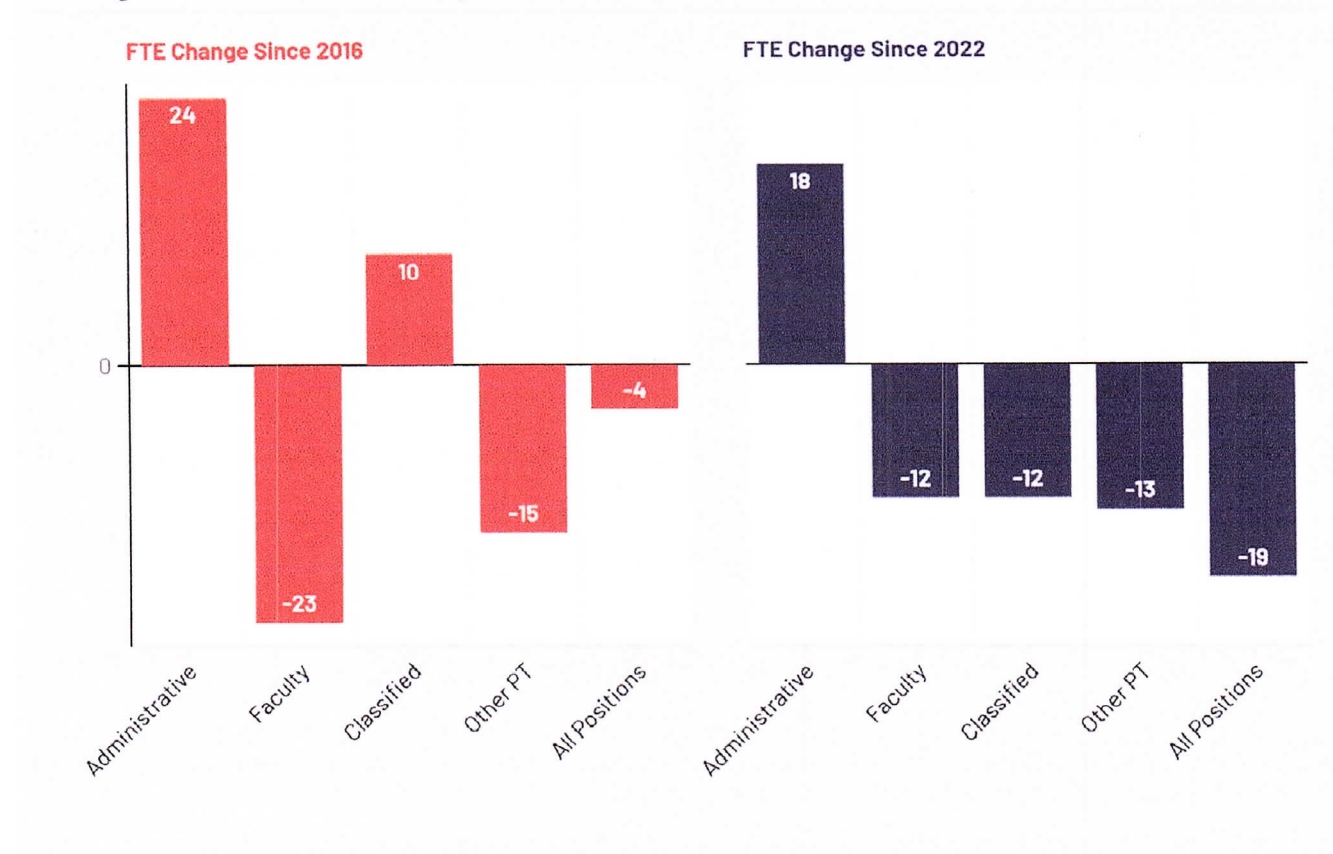

¹⁶ Clackamas Community College, Adopted Budgets, 2016-17 to 2024-2025. Position type is defined in the budget as follows: "Administrative employees are those who are exempt from the overtime provisions of the Fair Labor Standards Act (FLSA). Administrative professional employees are non-exempt FLSA covered in a bargaining unit. Full-time faculty are faculty in that bargaining unit. Classified includes staff in the classified bargaining unit and grant-funded non-exempt employees working half-time or more who are excluded from the bargaining unit. Associate faculty are instructors in that bargaining unit. Other Part-Time includes PT administrative and classified employees who work less than 15 hours/week and student employees." Administrative professional employees made up 16% of the administrative FTE in 2024 (10 FTE) and 18% in 2025 (12 FTE).
