Background:

The District is required to submit annually to the School Facilities Oversight Board (SFOB) a capital plan. This plan is used by the SFOB to determine whether or not additional school footage is required by the school district for student population growth.

We are requesting the SFOB begin studying whether or not we are approaching the need for additional building square footage at both the K-8 and 9-12 levels. Elementary levels are currently sufficient as calculated by the SFOB models. This request will start the process of analyzing our data. If determined a need is indeed present, this does not force District into any action, but provides additional options.

I move that the Governing Board approve the Fiscal Year 2026 Capital Plan and authorize Thomas Bogart, Chief Financial Officer, to transmit this document to the School Facilities Oversight Board on behalf of the District.
