Presentations/ Recognitions

Denton High Senior Taerim Kim has been named National Merit Finalist. He is among an elite group of about 1,500 finalists

throughout the United States who were named finalists in the 2008

National Merit Scholarship Program.

Three students' from Ginnings and W.S. Ryan Elementary was selected to have their artwork exhibited at the State Capitol in Austin in honor of Youth Art Month. More than 1,000 entries were submitted to the Texas Art Education Association with only 100

selected for the state exhibit.

Ruben Molinar, principal of Borman Elementary School, received the Distinguished Library Service Award for School Administrators by the Texas Library Association. The award was based on his support of the Borman library through staffing, scheduling, budgeting, and programming.

Update of Crisis Management Plan Theresa Grant presented the Board with an update to Senate Bill 11 requirements for security audits and multi-hazard emergency planning and preparedness. Ms. Grant provided background on requirements of Senate Bill 11, the status of compliance, accomplishments, needed improvements and highlighted the collaboration with city, county, and other municipalities in the four phases of emergency management – mitigation and prevention,

preparedness, response and recovery.

Transportation Grant Opportunities Gene Holloway, Director of Transportation presented the Board of Trustees with information concerning the status of the Texas Railroad Commission's Propane Initiative Programs in which DISD will collect funds to promote the use of propane vehicles to reduce emissions in Denton County & the DFW non-attainment area . DISD has the 4th largest Propane Bus Fleet in the State of Texas (77 buses) and initiated an Alternative Fuel Program in 1995. DISD's current bus fleet is 80% Green and with the approved 2007 bond funds the transportation department will purchase an additional 44 + new propane buses which will give rise to a fleet that is 95% - 100% Green.

Under the Railroad Commission of Texas Propane Tax Credit Program, DISD qualifies for a 50¢ per gallon tax credit for each gallon of propane purchased from October 1, 2006 to September 30, 2009. The estimated Propane credit total for 2006-2009 is \$600,000.00+. TRCC anticipates the program will carry over to 2012-13 with an estimated return to DISD of \$1,200,000.00+.

DISD could receive up to \$1,500,000.00+ in TRCC Propane Fuel Initiative Reimbursements as a result of the two programs currently in force and an additional \$284,000.00 from reductions in fuel costs. Potential benefit to DISD would be approximately \$1,800,000.00.
