Dear Superintendent Woods,

This letter serves as a follow-up to the 2023 Annual Summative Designations letter that you received last week notifying you that your district has one or more schools identified for school improvement status via the Illinois Accountability System. I write to share information and explain next steps regarding schools that were previously identified as being in Targeted improvement status on Report Card 2018 and due to a Targeted designation for the same subgroup(s) on Report Card 2023, have moved to Comprehensive improvement status. See Appendix A for a list of your district's schools that are in Comprehensive improvement status.

What is school improvement status?

School improvement status begins with an initial annual summative designation of Comprehensive or Targeted and continues for **four years**, regardless of changes in annual summative designations.

ISBE provides tiered professional and financial resources during the four-year period of school improvement status through the Department of School/District Improvement. The goal of school improvement is to build the capacity of school leaders to implement and sustain effective school improvement practices, ultimately assisting schools with exiting improvement status. Federal Title I, Part A, Section 1003 School Improvement funds support school improvement activities and services.

The first year following the designation is reserved for planning and writing the required School Improvement Plan (SIP), including the completion of a required school-level needs assessment completed in conjunction with an ISBE-designated vendor, American Institute for Research (AIR). The subsequent three years are reserved for implementation of the SIP. Comprehensive schools are assigned a School Improvement Coordinator to support them monthly through the school improvement process. See Appendix B for the full list of school improvement supports and requirements.

What is the School Improvement Grant and how long will my district receive funds?

- o The first year following the designation is reserved for planning. Schools designated Comprehensive improvement status receive \$55,000 in Title I, Part A, Section 1003 School Improvement Grant funds to support the planning year. Schools designated Comprehensive must use \$38,602 of the Title I, Part A, Section 1003 school improvement funds for AIR to administer the school-level needs assessment.
- o The subsequent three years are reserved for implementation. Schools in Comprehensive improvement status receive a base funding amount of **\$70,000** in implementation year one.

The purpose of the grant is to build the capacity of school leaders to implement and sustain effective school improvement practices. For schools in Comprehensive status, the funds will be utilized to pay for the school-level needs assessment conducted by AIR. Examples of other school improvement practices include compensating staff to work on School Improvement Plans, review data, conduct vertical and horizontal curriculum articulation activities, as well as releasing staff for collaborative planning time. When and how can my school exit school improvement status?

In general, schools exit school improvement status after completing the four-year school improvement cycle (i.e., one planning year and three implementation years) and meet the exit criteria. See Appendix D for the path to exit school improvement status for Report Card 2023 schools.

All schools are invited to attend the upcoming Multilingual Illinois Statewide Conference in Conjunction with ESSA Dec. 5-7 in Oak Brook. The conference will offer multiple school improvement focused sessions and tabletop discussions. This conference is an allowable use for both planning and implementation years within the Title I, Part A, Section 1003 school improvement funds. Registration information can be found here.
