

Public Hearing - FIRST Rating October 20, 2025

Purpose



Texas School districts are required to prepare and distribute an annual financial management report that includes financial performance ratings provided by the Texas Education Agency (TEA), the district's financial management performance under specific indicators, and additional information required by the commissioner under Texas Administrative Code Chapter 19.

Determination of Rating



2024-2025 Ratings contain 21 indicators

Critical Indicators (1-4)

Solvency Indicators (5 -14)

Financial Competence Indicators (15 - 21)

20 of the 21 indicators were scored

Indicator 10 continues to be paused

Determination of Rating



Rating	Points
A = Superior Achievement	90 - 100
B = Above Standard Achievement	80-89
C = Meets Standard Achievement	70-79
F = Substandard Achievement	<70

The school district receives an F if it scores below the minimum passing score, if it failed any critical indicator 1-4, or if the Annual Financial Report (AFR) or the data were not both complete or not submitted on time

Reporting Requirements



The district's financial management performance rating is provided by the Texas Education Agency (TEA) based on its comparison with indicators established by the commissioner for the state's financial accountability rating system.

The district's financial management performance under each indicator for the current and previous years' financial accountability ratings.

4	A summary schedule for the fiscal year of the total dollar amount of gifts with an economic value of \$250 or more received by the executive officers and board members.
5	A summary schedule for the fiscal year of the dollar amount received by board members for the total amount of business transactions with the school district.
6	Additional information that the district's board of trustees deems useful.
