Under the proposed policy, currently attending students are guaranteed acceptance (with no need to reapply) if they apply for Open Enrollment by April 30, 2013. If these students apply for an additional year tuition waiver for 2013-14 and wait until February 3-April 30, 2014 to apply for Open Enrollment in the 2014-15 school year, they are entitled to <u>preference only</u>, but <u>not</u> guaranteed admission.</p>	<p>February 3 - April 30, 2014</p> <p><u>Proposed Shorewood Policy:</u> Currently attending students (including tuition waiver students) who apply for Open Enrollment for the 2014-15 school year are entitled to preference, but <u>not</u> guaranteed admission under the proposed Board policy.</p>
