MEMORANDUM OF UNDERSTANDING (MOU)

BETWEEN EDUCATION SERVICE CENTER REGION 11

AND Argyle ISD

(District, Charter, ESC Name)

THIS MOU AGREEMENT is entered into by and between the Education Service Center Region 11, ("ESC Region 11") and Argyle ISD (collectively referred to as the "Parties" or individually as the "Party") acting herein by and through their respectively authorized officers or employees. This agreement shall be effective on the date it is executed by all the Parties ("Effective Date").

PREMISES

WHEREAS Chapter 791 of the Texas Government Code authorizes governmental entities, including education service centers and independent school districts, to contract with each other to provide governmental functions and services; and contracting party has a fully executed Master Interlocal Agreement (MIA) on file with ESC Region 11.

WHEREAS, the Parties wish to enter into this Agreement for the purpose outlined below and the parties agree to follow the agreed upon guidelines to provide the services in this agreement.

WHEREAS, each party, in performing governmental functions or in funding the performance of governmental functions, shall make that performance or those payments from current revenues legally available to that party; and

WHEREAS, each party finds that the performance of this Agreement is in the common interest of the parties, that the understanding will benefit the public interest and that the division of costs fairly compensates the performing party for the services or functions under this Agreement.

NOW THEREFORE, the Parties to this agreement mutually agree to the following:

- 1. DESCRIPTION OF SERVICE: 2024-2025
- 2024-2025 TEHCY SSA Services

2. PURPOSE / REASON

The purpose of the 2024-2025 Texas Education of Homeless Children and Youth (TEHCY) grant is to provide additional capacity, promote school stability, facilitate enrollment, identification, attendance, academic, and overall outcomes for homeless children and unaccompanied youth.

- 3. DUTIES AND RESPONSIBILITIES
- 3.1 ESC REGION 11 Duties and Responsibilities.

The REACH Team will coordinate work with Argyle ISD to provide professional development, individualized coaching sessions, technical assistance, and custom support as needed.

Argyle ISD (Obstrict or Charter name) Duties and Responsibilities.

McKinney-Vento staff will work collaboratively with the ESC Region 11 Reach Team to schedule one-on-one district coaching sessions, implement action items identified in coaching sessions and attend professional development to support McKinney-Vento

programming.
