On Wednesday, December 20, 2017, sealed bids were publicly opened at the Oak Park Elementary School District 97 Administration Building for the Holmes Elementary Additions & Renovations, Bid Group 1 trades, which included excavation, site utilities, structural steel and concrete. All remaining trades will be bid (Bid Group 2) at a later date. The summary of the bid information is reflected in the table below:

The original Bulley & Andrews recommendation included all four trades but was later adjusted to include only excavation, structural steel and concrete. Therefore, based upon the review of the bid results, Bulley & Andrews recommended the award of the following contractors:

The December FAC meeting was adjusted to allow FAC to review the bids to provide a recommendation to the Board so that the two Board meeting requirement could be waived. As the facilities experts, the committee's review should expedite the Board's approval process. On January 3, 2018, FAC reviewed the bids and recommended that the site utilities bid acceptance be postponed until after some suggested options could be explored. The site utilities bids will be approved at the February 13, 2018 meeting, but will not impact the project timeline. FAC agreed with the other recommendations presented by Bulley & Andrews at its meeting.

Please note that the bids must be approved at the January meeting in order for the project to be completed on time. Based in the FAC, Bulley & Andrews recommendations, and Board approval, the work is scheduled to begin in February for this phase of the Holmes project.
