B. Approval of Minutes – There was a motion by Cornell with a second by Clear Lake to approve the April meeting minutes. Motion passed unanimously.

C. Approval of Treasurer's Report–There was a motion by Cornell with a second by Luck to approve the Treasurer's Report. Motion passed unanimously after some discussion. 1. ALICE training in the Lakeland Conference (Birchwood)

Birchwood is working to schedule a local ALICE Training that will be made available to all Lakeland Conference Schools. Frank Helquist will keep the group informed of the plans as they are solidified.

2. Gilman Joining the Lakeland (Mark Heyerdahl Superintendent Gilman)

Mark Heyerdahl, the superintendent at Gilman, addressed the group to request that Gilman be allowed to join the Lakeland Conference for every sport except football. They would like to remain in the Cloverwood for football. There was some discussion regarding the balancing of the numbers between the separate conferences within Lakeland. Gilman has 108 in the high school. There was some concern regarding Gilman staying out of the conference for football and how that could impact future requests. It was referenced that the Lakeland Constitution requires 2/3 affirmative vote from all the members. As the number attending the meeting was close and that there may be need to further discussion, any action was postponed until fall.

3. Update on Lakeland Conference Dave Dewey

Dave Dewey opened by offering to answer any questions from the superintendent group. There was some continuing discussion about the three-person officiating crew in basketball, although the WIAA's use of these crews in the tournaments have served to effectively reduce the number of two person crews in action. There was also some discussion of some schools nto attending the conference meetings and how this can be detrimental to having a quorum at meetings to conduct business in a timely manner.

4. Items from Principals and AD's

There were no items to discuss or take action upon. Although, there was some discussion regarding the lack of communication from the principal and AD groups in recent months. 5. Future locations of Superintendents meetings

The 2014-2015 meeting location for the Superintendents Group was discussed. There is better technology access at CESA 11 and the meeting room was well received.
