Subject: External PE Report for 2023-24

Background Information:

This is an annual report regarding the External PE requirements and participation.

- Texas Administrative Code (TAC) § 74.F describes graduation requirements. When
 discussing P.E., it allows "appropriate private or commercially-sponsored physical activity
 programs conducted on or off campus." Approval may be granted from the
 Commissioner under following conditions:
 - Level I Olympic-level participation and/or competition includes a minimum of 15 hours per week of highly intensive, professional, supervised training. Students qualifying and participating at this level may be dismissed from one class period per day and may not miss any class other than physical education.
 - Level II Private or commercially-sponsored physical activities that are of high quality and well supervised by appropriately trained instructors. Student participation of at least 5 hours per week must be required. Students may not be dismissed for any part of the regular school day.
- Currently the following External P.E. courses have been approved (Level I or II): Archery,
 Clay Targets, Bowling, Dance, Equestrian, Fencing, Gymnastics, Ice Hockey, Ice Skating,
 Lacrosse, Martial Arts, Rock Climbing, Synchronized Swimming, Water Polo and Rowing
 in grades 6-12. Baseball, Golf, Softball, Wrestling and Swimming are approved at the
 middle school grades 6-8 only.
- Requests to add physical activity programs
 - Per the LISD Board Action item dated Nov. 14, 2011 "Superintendent or designee will approve future External PE courses upon recommendation from Athletic Director, Health/PE Coordinator and External PE Monitor(s)."
 - Per TEA, off-campus physical activity by private or commercially-sponsored programs must consist of Olympic-level participation or competition.

 LISD does not consider any activity or sport that we currently field a UIL team for competition. (Exceptions would be baseball, golf, softball, swimming and wrestling at the middle school level since our schools do not compete in those sports).

Administrative Consideration:

- External P.E. instructors must apply through LISD Human Resources for a criminal background check prior to approval. Parents are required to submit a completed application within the first 3 days of each semester.
- High school parents pay \$100 per nine weeks, or \$150 per semester, or \$250 per year for admission into External P.E. program. Middle school parents pay \$75 per semester or \$150 per year.
- Last year, there were 413 students enrolled in External P.E. (see below). As required by law, they are monitored by a full-time certified physical education teacher (Debra McDonald) who ensures all paperwork requirements and logged hours are met since LISD assigns credit for the course.
