<u>Literacy Plan Update</u>: Chief of Staff/Assistant Superintendent of Secondary Education Dr. Stephanie Howard and Literacy Director Jaime Miller provided Trustees with an update on the Literacy Program. Ms. Miller told Trustees that a study of reading scores showed a dip from 5th grade to 6th grade and to address this issue the District formed a team to lead Guided Comprehension – Reading to Learn. This team created a plan, trained teachers, and is providing support. One piece of the plan is the creation of literacy libraries at all middle schools, teachers will have grade-level materials ready to use as resources for their students. Interim Superintendent Jim Nelson told Trustees that a textbook adoption would be coming up in the spring and that it would be a key piece of this effort to improve reading throughout the District. - <u>Discussion of Lone Star Governance Progress Report</u>: Chief of Staff/Assistant Superintendent of Secondary Education Dr. Stephanie Howard led this discussion. The following goals and progresses were discussed:
 - 1.1 The Superintendent shall not allow a campus to remain in IR status for more than four years without a restart plan. Goal Met (Restarted Ector, Zavala, and Noel; Review Blackshear in January 2019)
 - 2.1 The Superintendent shall not allow a principal to remain on an IR campus for more than three years, and that principal may not remain as an administrator in the District. Goal Met (No principals in year three)

- 3.1 The Superintendent shall not hire any administrator in the District with less than five years of successful classroom experience. None
- 4.1 The Superintendent shall not place any Long-Term Substitutes in a core subject area on a campus that has been in IR status for more than one year. Blackshear Elementary Goal Met Bonham Middle School –

6th grade English (Long-Term Substitute) 6th/7th English (Certified Reading Teacher) 6th/7th Science (not tested)

- 5.2 The percentage of 1st year teachers at IR or high risk elementary or middle schools will not exceed the District average 6.83%. (District average is low due to unfilled positions and long-term positions not being coded as zero year/1st year teachers) Goal Met on three of eight campuses. (Blackshear 4.67%, Burnet 3.23%, Buddy West 12.90%, GP Alamo 4.17%, Bonham 22.81%, Bowie 8.45%, Crockett 10.45%, Wilson & Young 10.34%)
- 5.3 The number of IR or high-risk campuses to have a principal with less than three years' experience as administrator at IR or high-risk campuses will decrease from four to zero by the end of the 2019-2020 year. Goal Met
- 5.4 The Superintendent shall not hire a Principal at a high-risk or IR campus who has not had a successful experience as either an Assistant Principal or Principal at a high-risk or IR campus. Goal Met

Percentage of students earning 6+ credits by the end of 9th grade shall increase from 81% to 85% by 2020. Goal Met in 2018 (2018 – 85.2%; 2017 – 83.44%)

Percentage of students earning Algebra 1 credit by the end of 9th grade shall increase from 75% to 85% by 2020. 2018 – 77.53% - increase from 2017 (7.47 points from 2020 goal) 2017 – 75.17%
