- All portions of the December 3, 2025 meeting consisting of the full board shall be recorded and streamed online.
- Applicant interviews will be limited to 20 minutes each. Each board member will be given three minutes to ask up to three questions, the first of which must originate from the list provided by Member Theisen and reflect the question assigned tonight.
- Assigned questions are as follows:
 - Member Antonsen – How important is it for you to have a trusting relationship with the superintendent? (If important) How do you achieve this?
 - Member Rebelein – Describe the kind of relationships you want to have with your fellow board members.
 - Member Theisen – What would you intend that your major contributions be as a board member in this school district?
 - Member Christenson – What are your goals and aspirations from a personal point of view?
 - Member Kasel – What legacy would you like to leave as a result of your time on the school board?
 - Member Corcoran – If you have a decision to make, how do you go about making such decisions?

Chair Rebelein moved, 2nd by Member Antonsen to Accept the resolution as presented.

FOREST LAKE AREA SCHOOLS SCHOOL BOARD RESOLUTION

WHEREAS, the board previously established that applications to fill the vacancy would be accepted and that committees would select individual finalists to join the "highest unelected vote getter in the 2024 election" candidate; and

WHEREAS, after reviewing the applicants, Mrs. Laura Ndirangu has been identified as the highest unelected vote getter in the 2024 election among the applicants; and

WHEREAS, the board previously established that the committees shall meet on Dec 1st at 5pm at the Forest Lake Area School's District Office to determine their finalists.

THEREFORE, BE IT RESOLVED by the School Board of Forest Lake Area Schools ISD 831 as follows:

1. Mrs. Laura Ndirangu is named as the preferred finalist as the highest unelected vote getter in the 2024 election.
2. The school board is establishing two committees to each select up to two finalists in addition to Mrs. Ndirangu.
3. The first committee shall consist of Members Corcoran, Theisen, and Christensen. The second committee shall consist of Members Rebelein, Antonsen, and Kasel.
4. The committees will meet on December 3, 2025 at 5:00 pm at the Forest Lake Area School's District Office to interview all applicants using a schedule determined by administration.
5. Immediately following the committee meetings, the full board will meet, and each committee shall provide the name of up to two selected finalists to the full board.
6. All portions of the December 3, 2025 meeting consisting of the full board shall be recorded and streamed online.
7. Applicant interviews will be limited to 20 minutes each. Each board member will be given three minutes to ask up to three questions, the first of which must originate from the list provided by Member Theisen and reflect the question assigned tonight.
8. The special order of business of adopting a resolution naming one of the selected finalists to fill the seat vacated by former Member Hagglund shall be scheduled to take place at the December 4, 2025 board meeting.
