#### **Background Information:**

This is a standing item to bring change orders to the Board. (Administration will present about change orders approved as part of the delegated authority during the HPM Construction Update. This item is for approval of change orders that are not within the delegated scope of authority.)

Administration is asking the Board to approve the Honeywell change order for the HVAC Upgrade Project. We budgeted for \$10 million for this project. The HVAC project came in under budget and Administration determined that we could add to the scope including upgraded controls. Including this change order, the amount spent would be \$7.8 million, which is still under budget.

#### **Fiscal Implications:**

The HVAC change order cost is: \$1,166,474.

## **Administrative Recommendation:**

Administration recommends that the Board approve the change order.
