
### February 12, 2019 Rescheduled Regular Board Meeting

As Angel mentioned, Benefits/Health Insurance consulting services were procured outside of Buyboard through First Public, the wholly-owned subsidiary of TASB that administers the TASB Benefits Cooperative. As such, the procurement process was different than Buyboard and was directly approved by the TASB Benefits Cooperative Board of Directors.

I have attached signed minutes of the TASB Benefits Cooperative Board Meeting that names Gallagher as our awarded consultant to serve school districts (read item V in the attached board minutes). In order to procure Gallagher's services through the TASB Benefits Cooperative, your board would need to approve the attached TASB interlocal agreement.

Currently, over 100,000 school district employees in Texas are covered in some way through the products and services of the TASB Benefits Cooperative.

Good afternoon Delia.

Region One has utilized a consultant for the last three insurance/TPA proposals. A RFQ was not done for this service as the amount was far less than the \$50,000 threshold. We based our decision on demonstrated competence as allowed under Government Code 2254.027.

We can add this type of service when doing the Professional Consultant Services RFP after the current bid expires in 2022 or sooner if it is warranted.

I did a quick search for insurance consultants through most major cooperatives and only HCDE has related contracts, not for consultants, but for supplemental insurances.
