Subject: E-Rate Cisco Purchase

We are recommending the purchase of Cisco equipment from People Driven Technologies at a price not to exceed \$70,325.60. This purchase will be funded by the General Fund Technology Millage. With this being the 5th and final year of this round of eRate funding we have requested from vendors proposals for ten network switches and external wireless access points to extend the existing networks of Monroe Public Schools. This access point hardware will be used to add additional wireless coverage on the district grounds for use by students and staff of Monroe Public Schools. The network switches will be used for future expectations within the district, such as the relocated computer lab at Monroe High School and additional changes in the district. This purchase was bid out with two responses.

With this proposal, we received two responses.

People Driven Technologies - \$70,325.60

Moss Telecommunications - \$62, 214.50

We would like to recommend the purchase of the network hardware from People Driven Technologies. The reason for this recommendation is the equipment quoted by Moss Telecommunications did not match the requested hardware specifications which is the reason for the difference in the price.

What is E-Rate: Universal Service Program for Schools

The FCC's E-Rate program makes telecommunications and information services more affordable for schools and libraries. With funding from the Universal Service Fund (fcc.gov/general/universal-service-fund), E-Rate provides discounts for telecommunications, Internet access, and internal connections to eligible schools and libraries.

The ongoing proliferation of innovative digital learning technologies and the need to connect students, teachers and consumers to jobs, life-long learning, and information have led to a steady rise in demand for bandwidth in schools and libraries. In recent years, the FCC refocused E-Rate from legacy telecommunications services to broadband, with a goal to significantly expand Wi-Fi access. These steps to modernize the program are helping E-Rate keep pace with the need for increased Internet access.
