SUBJECT: Food Service prices – 2012-13

MOTION: That the Board of Education of Oak Park District 97 extend, for the 2012-13 school year, the Intergovernmental Agreement between Oak Park River Forest School District 200 and District 97 for the provision of freshly prepared meals as outlined in the memorandum to the Superintendent dated April 24, 2012.

BACKGROUND: At the meeting on April 30, 2012, a question was asked regarding the additional \$.18 for the additional bread portion for middle school students. This has been a part of the contract from its commencement and includes either an additional bread or juice component (child's choice) and has been \$.15 up until the proposed increase for the 2012-13 school year.

At its May 15, 2007 meeting, the Board of Education of Oak Park District 97 entered into an intergovernmental agreement with Oak Park River Forest High School for the provision of "cafeteria service and school meals for students attending its school facilities for the 2007-08, 2008-09, 2009-10, and 2010-11 school years. At its May 24, 2011 meeting, the Board of Education extended that agreement for an additional school year (2011-12) and, over the course of late fall/early spring of this school year, I was to explore other competitive opportunities for the provision of freshly prepared daily meal service for our students. Following this investigation, I would come back to you with a recommendation to either extend the existing contract or let a bid. Unfortunately, I have not even begun the exploration process.

Oak Park River Forest High School is willing to extend the existing agreement for another school year (2012-13) at no additional cost. Please note attached memorandum from Micheline Piekarski, the Food Service Director from the high school.

I am recommending we renew the contract with Oak Park River Forest High School for the 2012-13 school year, continue to work with the Wellness Committee in implementing all the new nutritional guidelines recently promulgated, and insure that between late fall/early spring of this year, complete the exploration of other competitive opportunities in order to timely make a recommendation to you on how to proceed for future school years.

This will return to the Board for formal approval at their May 8, 2012 meeting.

Re: Breakfast and Lunch Prices

There will not be an increase in the breakfast and lunch prices for the 2012-13 school year.

2012-13 Lunch Prices

- 1. The charge per meal will be \$1.00 for breakfast and \$1.65 for lunch, which will be used to calculate monthly invoices.
- 2. In an attempt to satisfy the nutritional needs of the 6th, 7th and 8th grade students at Brooks and Julian Middle Schools, an additional bread portion will be supplied daily for each student who orders a meal. The cost of this serving will be added to each day's bill at a rate of \$.18 per student.

AMENDMENT TO THE FOOD SERVICE INTERGOVERNMENTAL AGREEMENT

This Amendment to the Food Service Intergovernmental Agreement amends the Food Service Intergovernmental Agreement dated May 15, 2007 ("Food Service IGA") between the Board of Education of Oak Park & River Forest High School District No. 200, Cook County, Illinois (hereinafter "School District 200"), and the Board of Education of Oak Park Elementary School District No. 97, Cook County, Illinois (hereinafter "School District 97") (School District 200 and School District 97 are sometimes referred to collectively as the "Parties").

NOW, THEREFORE, IT IS AGREED as follows:

Its Secretary

- 1. The terms of the Food Service IGA are renewed for the one year period commencing on July 1, 2012 and extending to and including June 30, 2013.
- 2. For the renewal period of July 1, 2012 through June 30, 2013, Section 1, A., 6. of the Food Service IGA is amended to provide that the charge per meal for breakfast will be \$1.00 and the charge per meal for lunch will be \$1.65.
- 3. For the renewal period of July 1, 2012 through June 30, 2013, Section 1. A., 7. of the Food Service IGA is amended to provide that the cost of the larger serving for students at Brooks and Julian Middle Schools will be added to each day's bill at a rate of \$.18 per student.
