

6.2 PLACEMENT OF TENTATIVE 2025-2026 BUDGET ON PUBLIC DISPLAY AND THE ESTABLISHMENT OF A PUBLIC HEARING DATE

A. SUBJECT

This item appears on the agenda because the Board is required to establish a date and place for a public hearing which will be held after the tentative budget has been on public display for at least 30 days.

B. INFORMATION

The 2025-2026 tentative budget has been developed according to the guidelines established by the Board of Education. Article 17, section 105ILCS 5/17-1 of the School Code of Illinois states the following:

“Such budget shall be prepared in tentative form by some person or persons designated by the board, and in such tentative form shall be made conveniently available to public inspection for at least 30 days prior to final action thereon. At least one public hearing shall be held as to such budget prior to final action thereon. Notice of availability for public inspection and of such public hearing shall be given by publication in a newspaper published in such district, at least 30 days prior to the time of such hearing. The board may from time to time amend such budget by the same procedure as is herein provided for its original adoption.”

Administration is proposing that the budget be put on display on August 13, 2025, and that the public hearing and adoption of the budget take place on September 23, 2025.

The resolution to establish the public hearing date and place is attached and a separate document can be found for the 2025-2026 Tentative Budget with various schedules and exhibits providing supporting details. Superintendent Michael Moan and Julie Dillon, Chief Financial Officer, will review information on the tentative budget at the Board meeting.

C. RECOMMENDATION

The Superintendent recommends that the Board approve the tentative 2025-2026 budget, place it on public display and approve the accompanying resolution, which indicates that there will be a public hearing on September 23, 2025.

D. SUGGESTED MOTION

Move to approve the tentative 2025-2026 budget and waive the reading of and approve the resolution to establish the budget hearing date and place the tentative budget on public display.
