



DONATION OF ONE PORTABLE CLASSROOM BUILDING

POLICY ISSUE / SITUATION:

The District will be removing a total of eight portable classroom buildings from SHS and BHS this summer. Seven of these will be moved to other schools to address overcrowding pending new capacity construction. The remaining portable is 17 years old and is ready to be retired due to its condition. School Board Policy DN states that the Board may declare district property to be surplus and authorize its disposal.

BACKGROUND INFORMATION:

- The Joint Regional Operations Center (JROC) Foundation has approached BSD about the potential of having the excess portable donated to support training of first responder professionals in Washington County. A formal letter request was submitted, Attachment (1).
- The Washington County Sheriff has endorsed this request, Attachment (2).
- Donation of this portable, currently located at SHS, would avoid costs for transporting and disposing of this building. BSD would donate it in as-is condition. JROC would bear the responsibility for removing it from SHS property and for all costs associated with transportation and set-up at the new location.
- Supporting this request would be consistent with BSD's long partnership with law enforcement agencies in Beaverton and Washington County.

RECOMMENDATION:

It is recommended that the Board declare this portable to be surplus and authorize its disposal via a donation.

(14-432) BE IT RESOLVED that the Beaverton School District Board of Directors declares Portable (Inventory Number 9702) to be surplus and further authorizes donation of this surplus property to the Joint Regional Operations Center Foundation.

This letter serves to convey my strong support of a request you are considering from the Joint Regional Operations Center (JROC) Foundation to donate a portable classroom to JROC in Washington County.

As you seek to surplus or otherwise dispose of other such assets, please consider the educational function that could be extended in the public safety realm.

The JROC site in rural Washington County presents the opportunity for a private public partnership to deliver a dynamic real-world training environment for first responder professionals within Washington County to train. However, it is currently in the early developmental stage. To improve the use of this site and better welcome public safety agencies, an indoor portable classroom is needed for training police officers and other first responders to meet and receive classroom instruction prior to and after training exercises.

I have signed an agreement with JROC Executive Director Brian Lynott to ensure my deputies could train on the site near Timber, Oregon. Since then, my staff has continued dialogue with JROC to consider how the non-profit organization could strengthen collaboration among regional law enforcement partners who may want to utilize the training center.
