Lake Orion Community Schools, in partnership with Clarkston Community Schools, requested bids for filtered water equipment to support the Filter First Healthy Hydration initiative. The request for proposal (RFP) was developed in accordance with district standards and specifications.

The RFP was advertised in the local newspaper, on the SIGMA website, and on the district website. Bids were received on January 13, 2026. Based on the unit pricing submitted, we're recommending award to each bidder on a not-to-exceed basis.
