Remote Special Education Homebound Services

**General Questions**
**1. Give a brief narrative description of the requested waiver.**

Denton ISD is requesting a waiver to serve a special education student remotely for homebound services. Due to the student's medical condition, she cannot attend in person instruction. The special education homebound teacher has been servicing the student remotely, but will accrue 20 hours this week. The students meets special education remote homebound criteria.

Yes: Students will graduate college, career, and/or military ready (CCMR)

**4. Describe the plan to be implemented, if the waiver is granted.**

The special education homebound teacher will meet remotely with the student for at least 4 hours per week. The teacher will assist the student in communicating with teachers on a daily basis. In addition, the teacher will ensure that the student's Individual Education Plan (IEP) is implemented with fidelity. Instructions will be provided synchronously by a special education certified teacher who is not teaching in-person students at the same time. The student meets the criteria for special education remote homebound services.

**5. How will granting this waiver help achieve the district's or campus' objective?**

The student's IEP will be implemented appropriately and with fidelity to ensure the student is college, career, and/or military ready by graduation.

**6. Please explain how the school district or campus will evaluate the impact of the waiver towards meeting the district's or campus' goal.**

The campus will evaluate the impact of the waiver through the student's qualifying CCMR criteria in addition to the student's progress on STAAR exams.
