Alternative Evaluation Process

- 2 Criteria Points
 - Campus must have been rated D, F in 2019 (or IR in 2018)
 - <u>AND</u> must have had a 95% participation rate (All Students, all subjects combined)
 - 5 Campuses with Overall D/F...all of which did not meet the participation requirement of 95% to be eligible.

CSI, TSI and ATS-2019 Labels Carry Over

 Comprehensive Targeted Support- 2 campuses

HOWEVER

- Pathways-earned comprehensive support exit due to meeting the graduation rate criteria
- West Ward-campus closed
- Target Support 18 campuses
- Additional Target Support 3 campuses

Targeted Improvement Plans

- No submissions to TEA are required this year for overall F campus.
- TEA is not requiring any TIPs to be approved by the board this year.
- Campuses that are overall D/F, will complete the TEA TIP and maintain it locally.
- Campuses that are D in a Domain, targeted support and additional target support will embed their improvement plan within their campus improvement plan.






Domain 2 – Part A – Academic Growth

Domain 2 – Part B – Relative Performance-Elementary/Middle School Campuses







Accountability 2022

State Accountability

- Districts and campuses will be assigned A-F letter grades (overall and for each domain)
- HOWEVER, if the overall rating would be a D or an F, TEA will assign a rating of "Not Rated"
 - that would mean that for purposes of determining "consecutive years" of low ratings, a district or campus could be considered to have consecutive years of low performance based on ratings from 2019 and 2023
- Accountability re-set will occur in 2022-2023.

Federal Accountability

 Federal Labels issued in August 2022 will likely be linked to labels issued in August 2019 (subject to USDE)
