<b>Meeting Date</b>	December 16, 2024
<b>Action</b>	Discuss and consider the approval of the 2019 – 2026 Amended San Jacinto Community College Dual Credit Memorandum of Understanding.
<b>Motion</b>	I move to approve the 2019 – 2026 Amended Dual Credit Program Memorandum of Understanding between San Jacinto Community College and Crosby ISD.
<b>Administrative Recommendation</b>	The Administration recommends approving the 2019 – 2026 Amended Dual Credit Program Memorandum of Understanding between San Jacinto Community College and Crosby ISD.
<b>Authority for this Action</b>	<p>EHDD (LOCAL) – Alternative Methods for Earning Credit: College Course Work/Dual Credit</p> <p>An eligible student may enroll in a partnership program with a Texas college or university in accordance with an agreement between the District and the college or university.</p>
<b>Goal/Objective Addressed</b>	<p>District Goal #1 College or Career Readiness:</p> <p>Graduates of Crosby ISD will be prepared for success after high school by being adequately prepared for either college or work force success.</p>
<b>Background</b>	<p>The purpose of this agreement is to outline the responsibilities maintained by both Crosby ISD and San Jacinto Community College regarding the instruction of Dual Credit Courses. The agreement outlines the location in which classes will be held, scheduling of classes, faculty responsibilities, financial responsibilities, curriculum and instruction, academic policies, student eligibility, and the awarding of credit.</p> <p>The updated San Jacinto Community College MOU amends the following section:</p> <ol style="list-style-type: none"><li>1. The Section entitled "TERM OF AGREEMENT," found on page 11 of the 2019 MOU, is hereby deleted and replaced in its entirety with the following:  TERM OF AGREEMENT a. <u>Term</u> The term of this MOU shall be from the Effective Date through July 31, 2026, unless renewed or earlier terminated as set forth herein.</li></ol>

	<p>b. <u>Termination</u>  This MOU may be terminated by either Party, with or without cause, upon one hundred and eighty (180) days' prior written notice to the other Party. However, in the event of such termination, any CISD students taking SJCCD college courses for dual credit at the time this MOU is effectively terminated will be allowed to complete those courses notwithstanding the termination of this MOU.</p> <p>The San Jacinto College catalog can be accessed at the followed link: <a href="#">Catalog Link</a></p>
<b>Staffing Implications</b>	Course instruction will be provided by existing Crosby ISD staff and/or San Jacinto Community College professors.
<b>Budget Information</b>	<p>There are new financial implications related to this MOU. Crosby ISD will be obligated to cover the cost of books and materials per semester for FAST eligible students. San Jacinto College will cover tuition and fees. The total per semester cost of books and materials will fluctuate based on the number of FAST eligible students enrolled.</p> <p>Students not eligible for the FAST program will continue to cover the cost of tuition, books, and materials.</p>
<b>Impact of this Action</b>	Approval of this agreement will allow Crosby ISD students to enroll in dual credit college coursework and satisfy high school credit requirements while simultaneously earning college credit through San Jacinto Community College.
