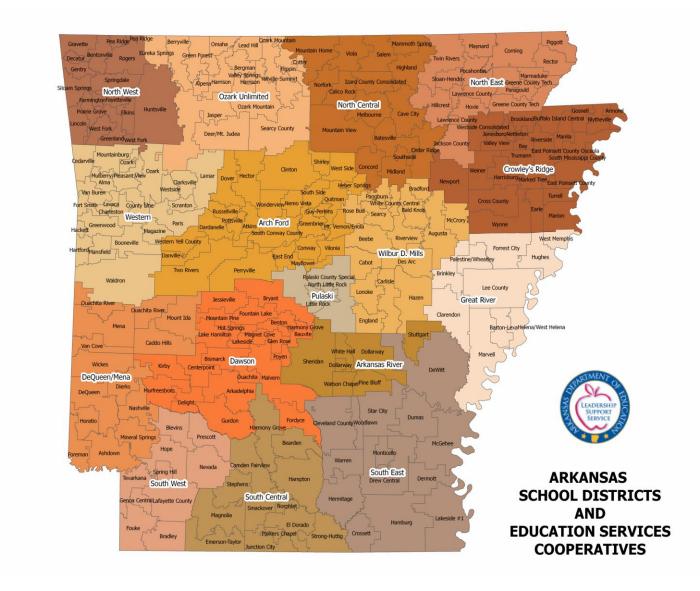

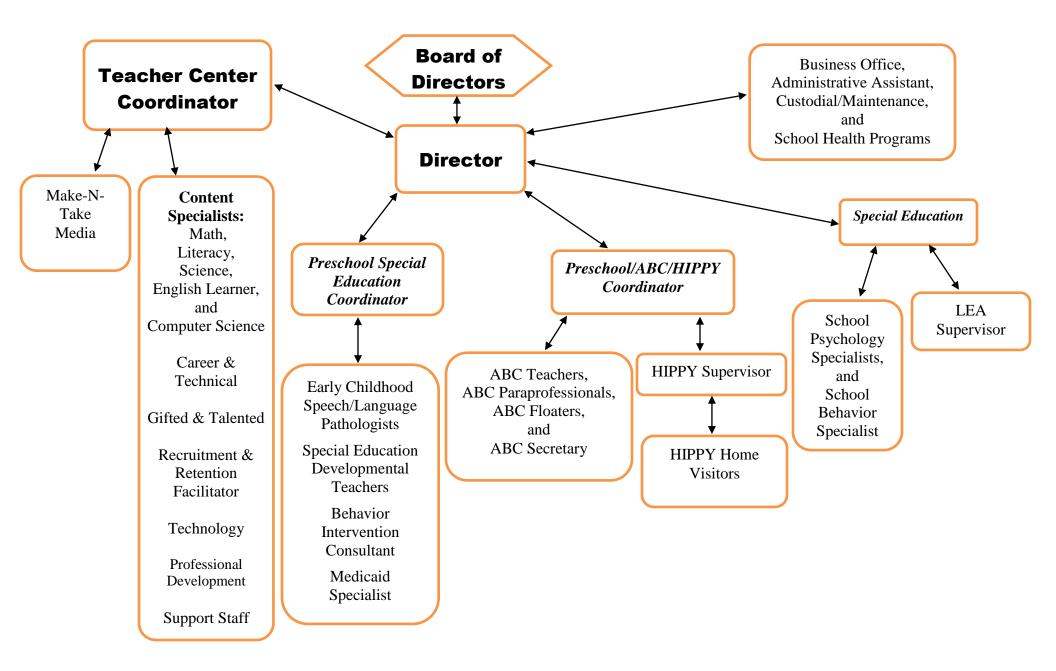

## Visual and Performing Arts Festival:

This Visual and Performing Arts Festival has been an annual event for the past 20 years. This years festival had over 250 participants from Cooperative districts. We were honored to have Dr. Bob G. McGee from Williams Baptist University as our emcee. Dr. McGee has served as Professor of Music; Chair, Department of Fine Arts and Director of Choral Activities for the past 37 years.

**Teacher Day:** NEA Cooperative hosted their annual "Teacher Day" on August 11, 2021. Due to Covid-19 regulations, the Annual Teacher Day was held virtually.

The morning session training was on State Mandated Child Maltreatment and was presented by Mack Dan. This session fulfilled the 2021-2022 professional development requirement of Child Maltreatment training.

The afternoon session was *Ole Pete Key* - Mansfield Key is an International Motivational Speaker whose goal is to educate, encourage, empower and equip individuals and organizations to grow and develop strategies to live a better life personally and professionally. He presents himself as the character "Ole Pete Key" and makes a huge impact while in character. His goal is to motivate others to unlock their potential.

## Athletic Coaching Institute:

The Athletic Coaching Institute is a two-day annual collaboration between ASU, Crowley's Ridge Education Cooperative and the Northeast Arkansas Education Cooperative. For over a decade Ron Carrol, director of the Institute, has provided trainings on-site at ASU on a variety of topics.

The Behavior Support Specialists (BSS) affiliated with the Arkansas Department of Education -Special Education Unit provide training and coaching as part of the BX<sup>3</sup> (Behavior eXtreme 3 – Training, Coaching, Empowering) project. The BX<sup>3</sup> project is designed to build the local capacity of districts in working effectively with students with challenging behaviors and is aligned to the Arkansas State Systemic Improvement Plan.

This multi-year initiative has two goals. The first goal is to increase the knowledge base and capacity of educators regarding the development of legally defensible Functional Behavioral Assessments (FBA) and Behavioral Intervention Plans (BIP) based on evidence-based practices. This will be accomplished through providing district BX<sup>3</sup> teams with professional development around effective supports for students exhibiting moderate and severe behaviors followed by on-site coaching opportunities. The second goal is to empower the BX<sup>3</sup> team to develop, train, and sustain behavior-related procedures across the district to improve the outcomes of students with challenging behaviors.

#### MAJOR HIGHLIGHTS OF 2021-22:

- 100% retention rate from Year 2 to Year 3 for Cohort 2
- Cohort 2 included five districts serving underrepresented areas

- Specialists have developed and will deliver 9 new trainings this summer. This is in addition to the other 20 trainings to be taught this summer.
- Specialists are currently working to visit all 264 districts to help support their implementation of ACT 414. This work will continue through the remainder of the year and summer. Our goal is for all districts to go into 2022-2023 with an identified plan of implementation.

- For districts who currently do not have an identified CS teacher the specialists are working to help identify personnel who may be able to fill that role and school needs.
- For districts who already have computer science programs in place, specialists are working to identify ways to grow and develop their program to fit their needs.

The Digital Learning Unit Specialists support digital learning on all levels. Our structure is designed to offer support, guidance and build capacity in those we work with, including educators and students. This invoices supporting through various avenues including, but not limited to, instructional support for integrating digital learning, designing online instruction in a preferred online platform, supporting social-emotional learning in online and blended

environments, facilitating effective PLC processes for both in-person and virtual teams, and incorporating student involvement and voice in digital learning.

## **PROGRAM SUMMARY:**

The Digital Learning Unit works within the state team to support Arkansas' planning, implementation, and evaluation of digital learning environments in Arkansas. The Digital Learning Unit has expertise in emerging online teaching and learning practices that allow for active learning; effective content authoring and lesson design methods that best serve digital education; and strategies in helping educators transform system-center practices into studentcenter practices. The Digital Learning Unit offers operational support to state projects, Arkansas Cooperatives and public schools in the area of digital learning.

## Arkansas Connect2Digital:

Arkansas Connect2Digital is a digital platform where Arkansas educational agencies house digital resources and implement blended and online professional learning. It supports 20,000 users and is managed by Team Digital. In addition to professional learning, the Connect2Digital.org platform is used to deliver the Arkansas Civics Exam, which supports over 100,000 users, including administrators, teachers, and students. We also manage the Arkansas Online Teaching Assessment, an evidence-based performance assessment designed for candidates seeking an exception area endorsement to add to the Arkansas educator license.

Due to COVID, we are still experiencing some parents that chose not to send their child to a center, so those children had to receive services individually. This is a collaborative relationship among the Early Childhood coordinators and the LEAs for the schools that serve the preschool and school age special education population in our region.

**GOAL:** The goal of the Northeast Arkansas Education Cooperative's Gifted and Talented Program is to assist member districts in coordinating, implementing, evaluating and improving local programs for gifted and talented youth. This goal is pursued through two primary objectives: (1) to develop and implement the Co-op's technical assistance activities in gifted education and to assist member districts to meet the standards for gifted and talented education; and (2) to provide a liaison with the office of Gifted and Talented Education, DESE, parent and professional organizations, and other public and private agencies and conduct public awareness and advocacy programs.

#### **PROGRAM SUMMARY:**

During the 2021-22 school year a broad range of services were provided that incorporated the five strands: on-site consultation and technical assistance; curriculum materials and resources; in-service and staff development; K-12 student activities; community involvement, and professional development activities. Specific needs of school district G/T Coordinators, Facilitators and students were addressed through the following activities and /or presentations: Project Fair for students in grades K-12; a creative writing project called the Story Store for students in grades 3-6; Four Quiz bowl competition for students in grades 3-12; Odyssey of the Mind competition for students in grades K-12; and Business Expo in grades 4-9, Chess Competition in grades 4-12.

Staff development opportunities included: Whole Group Enrichment; Chess Strategies along with ongoing work on our GT Frameworks. The GT Specialist met monthly and communicated weekly and daily with the ADE and other GT Specialists to gather and exchange information on current trends, practices and programs in Gifted Education. This information was shared with all district GT Coordinators.

Families participating in HIPPY receive all books and learning materials free of charge from their local program.

#### **PROGRAM SUMMARY:**

HIPPY is a developmentally appropriate, early literacy curriculum designed to promote children's cognitive, social, emotional and physical development. The curriculum consists of a set of easy-to-use educational activity packets and storybooks developed for parents of children ages 2-5. Parents engage with the curriculum by role playing the parent-child activities with a home visitor who is from the same community, and often a former HIPPY parent. All

home visitors are supervised by a professionally trained program coordinator. Through the delivery of the HIPPY curriculum, home visitors empower parents to build strong relationships with their children through activities and engagement that prepare them for school. The HIPPY model has four components:

- Curriculum
- Role Play
- Coordinators & Home Visitors
- Home Visits and Group Meetings

Each of the four features of the HIPPY model was chosen and developed in order to allow participation from parents who might otherwise not get involved with their children's education. Although HIPPY is for any parent who wants educational enrichment for his/her child, the HIPPY model was designed to remove barriers to participation due to lack of education, poverty, social isolation and other issues.

# MAJOR HIGHLIGHTS OF THE YEAR:

- The NEA Education Cooperative HIPPY program served 90 families this year with a total of 97 children. Some families include: single or divorced parents who are trying to raise children on their own, foster parents, and grandparents who are starting parenting again with grandchildren.
- Cheryl Gookin was awarded 10 years of service from the HIPPY Arkansas office. She is our HIPPY HBE that serves families in Clay county.
- Monthly parent meetings have included Fall field trips to Pumpkin Hollow and Autumn Woods. Healthy meal ideas for families with hands-on cooking; a Winter celebration; a visit from Cat-In-The-Hat during Dr. Seuss month that included book rewards for participation in a month-long reading contest, visits from kindergarten teachers from various schools to inform parents of the school's expectations as well as what parents can do to make their child's educational experience optimal, visited and toured local fire departments to learn about Fire Safety and what children can expect when they see a firefighter in full uniform, and ended with a End of Year Celebration at Ultimate Air Trampoline park to celebrate the 19 HIPPY Program graduates.
- Advisory Team was made up of 21 individuals from each local community of the five counties we serve. We had three meetings this year held at the NEA Education Coop. The luncheons included guest speaker, Gregg Cooper, ABC Coordinator, as he spoke on Adverse Childhood Experiences and guest speaker from UAMS, Kimberly Whitman, LCSW, on the topic of Identifying & Recognizing the signs of Childhood Trauma.

**Goal:** To provide the support, assistance, training and encouragement to the Novice Teachers from among the 13 participating NEAEC member school districts in order that each NT can become an effective, knowledgeable teacher and remain in the teaching profession.

## **PROGRAM SUMMARY:**

The **Recruitment and Retention Facilitator** mentored **155 Year 1, Year 2 and Year 3 Novice Teachers** in the school year 2021-2022. On-site classroom visits were still limited early in the Fall semester due to the new variants of Covid-19; however, approximately 165 classroom visits were made throughout the school year as well as virtual supports with individual Novice Teachers and correspondences through Zoom, phone and email.

Year 1 Novices attended a 2-Day **Boot Camp** training to be "Day 1 Ready" for the classroom. Year 1 Novice teachers also came to training 3 times during the school year as did Year 2 and Year 3 Novices. Connections were made with the new teachers as they were hired. During those informal meetings, the Recruitment and Retention Facilitator touched based with all Novices to provide updates and gather data to determine assistance needed.

# Year 1 Novice Teacher Trainings:

**Day 1** – **"Novice Teacher Boot Camp – Part 1"** was offered 4 times (7/21/21, 7/22/21, 8/4/21, 9/14/21). This training was designed for Year 1 NT's to be "Day One Ready" to enter the classroom. 4 separate 2-day trainings were provided to accommodate teachers hired at a later time. This training provided teachers with an Orientation into the Novice Teacher Program. Individual data was retrieved on various topics such as their individual routes to licensure, area of teaching, school district, and updated contact information, etc. Topics covered on this day included: introduction to ESCWorks, E-School Training provided by Pam Beach, introduction to "Survive and Thrive," introduction to Arkansas Ideas, introduction to NEA website and Facebook page, Grouping teachers with NEA Cooperative Specialists for the purpose of forming PLC's, discussion of Praxis supports, identification of EdPrep providers, and sharing "Teaching Channel" connections.

**Day 2** – **"Novice Teacher Boot Camp – Part 2"** was offered 4 times (7/27/21, 7/28/21, 8/05/21, and 9/17/21). During this session, teachers were trained on Student GPS, Arkansas Digital Sandbox, Data Privacy and Security Best Practices. Also discussed were Mentor Goals and

Responsibilities, "Buddie" mentors at their schools, receiving "Rocket Notebooks" provided to each teacher and explanation on how to use the resource, Social Emotion supports and handouts, "The First Days of School" PowerPoint on book by Harry and Rosemary Wong, and discussion on how to teach virtually.

**Day 3 – "How to Build and Design a Digital Lesson,"** provided by Arkansas Digital Learning Unit, 10/19/21 (Morning and Afternoon Sessions).

**Day 4 – "Social Media Ethics"** with Dr. Daniel Pennington 1/25/22, Virtual Morning and Afternoon Sessions.

**GOAL:** The goal of the Science Specialist is to provide ongoing support for adult learning in best practices in science education. This support includes raising awareness of the AR K–12 Science Standards and providing implementation tools and techniques to achieve success.

**PROGRAM SUMMARY:** The office of the Science Specialist supports teachers, administrators, and schools by providing quality professional learning opportunities and ongoing site-based support in instruction, leadership, and best practices. Instructional support such as statewide science professional development (i.e., GPS 101, ACT Aspire & SEPs, Assessment, and Unit Development) was provided to support implementation of the Arkansas K–12 Science Standards, model and provide resources for phenomena-based instruction, and incorporate ELA and Math standards. Support for Science Novice teachers was provided through on-site visits and observations. Science content was addressed through various texts such as *Disciplinary* Core Ideas: Reshaping Teaching and Learning, which informs K–12 science content while addressing Literacy Standards, Science Standards, science inquiry, and the storyline model of instruction. Digital Science Cafés were held in collaboration with other Cooperatives throughout the year to address digital teaching resources and strategies. Resources such as lessons, digital learning tools, texts, and virtual labs were also provided during the Science Café sessions. Onsite visits to support the creation and delivery of assessment tasks, engineering, classroom management, and lesson/unit planning occurred throughout the year. Professional learning opportunities for science focused on awareness of, transitioning to, implementation of, or sustaining the Arkansas K–12 Science Standards, STEM, and Solution Tree training sessions. An Innovative Partnership with Williams Baptist University was approved that brought pre-service teachers to the coop. These pre-service teachers were directly instructed in the Grasping Phenomenal Science PD sessions and piloted the Anchor Phenomenon PD. This partnership increased awareness of the AR K–12 Science Standards among the pre-service teachers, understanding of the importance of phenomena first science, and gave practical experience through student placements and lesson development. 150 digital licenses were purchased of the 4 core Uncovering Student Ideas in Science books. These licenses will be distributed to teachers for use but will revert to the coop when necessary. Teachers will receive training during PD and ongoing support through Cadres for the use of the assessment tools in the books. Professional development will be face-to-face this year. New professional developments

were developed to integrate science and literacy in grades K–5, use story lining and investigations in 6–8, and support the storyline process with anchoring phenomena.

**PROGAM SUMMARY:** The office of the State Science Specialist supports Science Specialists, schools, teachers, and administrators by analyzing GPS and Cadre Survey Data, implementing FY 2020 plan for GPS PD revision and development based on data, including district needs surveys, implement a Cadre follow-up support system and develop science curriculum and assessment resources accessible to Arkansas teachers. Mentoring and support was provided to the educational service cooperative science specialists through guiding, planning and implementing school support based on Grasping Phenomenal Science (GPS) strategies and goals and ACT Aspire Data, providing professional development to the specialists, and assisting ESC specialists in meeting their grant objectives. Mentoring and support was provided regionally through this position, with five different cooperatives being supported, Northeast, North Central, Crowley's, Arkansas River and Great River. GPS PD that was created and/or revised for FY 2020 was Unit Development, Science Assessment, and ACT Aspire and the Practices. Rehearsals for each of the PD's were held with each Science Specialist, while sharing tools and resources essential for delivery and implementation. A K-12 Unit Development pilot was also implemented with teachers from the NE Education Cooperative, consisting of over 75 teachers representing Kindergarten through Chemistry. These grade banded groups met each month from October to March, while engaging in a step by step process of a modified version of Understanding by Design. Products that were created were a scope and sequence for the year, phenomena driven PE bundles, essential questions and enduring understandings, assessment tasks and lesson level plans. This process will continue over the summer and throughout the next school year. During the last quarter of the school year, with AMI learning methods in place, bulleted lists of learning activities were created from PBS programs for Pre-K-8<sup>th</sup> grade students, along with vetted lists of content resources, strategies and tools for all grade levels. GPS PD session ACT Aspire and the Practices is being converted to a digital platform, in order to meet the needs of teachers over the summer.

### **Program Summary:**

Educators Rising is a career and technical education (CTE) movement that aims to inspire high school and college students to serve their communities by entering the field of education. By establishing a pathway starting in high school, Educators Rising assists districts in cultivating their own next generation of highly skilled educators through a "grow your own" initiative. In addition, Educators Rising strives to diversify the educator workforce as future educators explore the necessary skills to teach equitably and add student voice to national discussions around education.

The Educators Rising program is a state affiliate of the national Educators Rising organization administered by Phi Delta Kappa International. As a state affiliate, schools with pre-educator programs have access to student micro-credentials, rigorous curriculum and standards,

scholarship opportunities for students, EdRising Virtual Campus (resources, videos, and lesson plans), and opportunities to network through region, state, and national events.

The EdRising regions are determined by counties rather than ESC boundaries. However, Region Three is comprised of districts from the Crowley's Ridge ESC, Northeast AR ESC, and Woodruff County (Wilbur D. Mills ESC).

## MAJOR HIGHLIGHTS OF THE YEAR

Through collaboration between the Region Three Coordinator, CRESC facilitators, NEAEC facilitators, and the Arkansas State University ERZ Director, the 2<sup>nd</sup> annual Region Three Educators Rising Conference and Competitions were held on the campus of ASU on December 8, 2021. Nearly 100 students and guests from participating districts were present. Conference attendees heard the 2022 Arkansas Teacher of the Year, Susanna Post, give the morning keynote address. The afternoon keynote speaker was Mr. Ross White, Director for DCTE, followed by a panel discussion with current ASU education majors, the ASU ERZ, and the ASU Director of Professional Education Programs. Interspersed throughout the day were video presentations of education majors from area colleges and universities, group-building games, and visits to booths set up by various universities across the state. The conference concluded with awards presentations for the competition winners. Ms. Raven Harris, AR EdRising State Coordinator, assisted with handing out the awards and spoke to the students about the state conference.

Students from participating districts competed in the categories of "EdRising Moment," "Literature for K-3," "Job Interview," "Lesson Plan and Delivery," and "Ethical Dilemma." First place winners qualified to compete at the National Educators Rising Conference in Washington, D.C. in June 2022. \*Results of the national competitions were not available at the time publishing the Annual Report.

The Region Three Coordinator worked in tandem with a select committee of state and regional coordinators to plan the Arkansas Educators Rising State Conference, held on the Campus of the University of Central Arkansas in Conway on April 5, 2022. A virtual conference was held concurrently. Over 300 students from across the state attended the on-site conference, with several attending from Region Three. The virtual conference was attended by over 100 students. Topics for conference sessions included mental health first aid, college student panel discussions, and STEM activities. EdRising chapter sponsors and CTE coordinators were offered additional sessions targeted to their needs.
