#### Inclusive School Climate Pilot Update

Superintendent Lutz reported the first Inclusive School Climate staff development opportunity was held in September and the next training will be October 22. The training is presented by the Minnesota Department of Education and Peacemaker Resources.

The first meeting of the Diversion Committee was held on October 8. Staff have also participated in trauma sensitive training and "Understanding Ojibwe Cultural Behavior in School Activities" training offered by district Indian Education staff.

# **Class Size Report**

Superintendent Lutz reported on class size as recommended in SBR 400-30-1R: Class Size. Three out of 104 elementary classrooms exceed the guidelines. Five out of over 250 Bemidji High School courses exceed the guidelines by one student. No action was taken.

# **Truancy Tracker Program**

Superintendent Lutz reported on the Truancy Track Programs at Bemidji Middle School and Bemidji High School. Middle School students are making progress. High School students are adjusting nicely and 75% of the students are no longer considered truant.
