**AGENDA ITEM: 9.3**

**TOPIC: RESOLUTION ESTABLISHING PRECINCTS, DESIGNATING POLLING PLACES AND DESIGNATING HOURS FOR VOTING FOR SCHOOL DISTRICT ELECTIONS NOT HELD ON THE DAY OF A STATEWIDE, COUNTY, OR MUNICIPAL ELECTION**

**BACKGROUND:** Statewide law requires us to update our precinct locations as a result of the legislative redistricting process.

**PROCESS:** After consulting with election officials in Washington County, we are recommending separate precincts located in the cities of Forest Lake and Hugo, Washington County, because they will run as separate locations and accumulate results separately.

**RECOMMENDATION:** Adopt resolution establishing combined polling places for school district elections not held on the day of a statewide, county, or municipal election.

RESOLUTION ESTABLISHING PRECINCTS, DESIGNATING POLLING PLACES  
AND DESIGNATING HOURS DURING WHICH THE POLLING PLACES WILL  
REMAIN OPEN FOR VOTING FOR SCHOOL DISTRICT ELECTIONS NOT HELD  
ON THE DAY OF A STATEWIDE, COUNTY, OR MUNICIPAL ELECTION

BE IT RESOLVED by the School Board of Independent School District No. 831, as follows:

1. Pursuant to Minnesota Statutes, Section 205A.11, the precincts and polling places for school district elections are those precincts or parts of precincts located within the boundaries of the school district which have been established by the cities or towns located in whole or in part within the school district. The Board hereby confirms those precincts and polling places so established by those municipalities.
2. Pursuant to Minnesota Statutes, Section 205A.11, the board may combine several precincts into a single precinct for school elections not held on the day of a statewide, county, or municipal election. The following combined school district voting precincts are hereby established for all school district special and general elections not held on the same day as a statewide, county, or municipal election:

Precinct 1 encompasses all territory in ISD 831 located in the township of May and city of Scandia, Washington County, MN.

Precinct 2 encompasses all territory in ISD 831 located in the municipality of Lino Lakes, Anoka County, MN.

Precinct 3 encompasses all territory in ISD 831 located in the township of Linwood, Anoka County, MN.

Precinct 4 encompasses all territory in ISD 831 located in the municipalities of Columbus, East Bethel and Ham Lake, Anoka County, MN.

Precinct 5 - 9 encompasses all territory in ISD 831 located in the cities of Forest Lake and Hugo, Washington County, MN.

Precinct 10 encompasses all territory in ISD 831 located in the cities of Chisago City, Stacy, and Wyoming, Chisago County, MN.

3. Pursuant to Minnesota Statutes, Section 205A.11, the following polling places are hereby designated for said combined precincts for all school district special and general elections not held on the same day as a statewide, county, or municipal election:

4. Pursuant to Minnesota Statutes, Section 205A.09, the polling places will remain open for voting for school district elections between the hours of 7:00 o'clock a.m. and 8:00 o'clock p.m.
5. The Clerk is directed to file a certified copy of this resolution with the Washington County Auditor within thirty (30) days of the date of its adoption.
6. A single set of election judges shall be appointed to serve in each polling place.
7. The Clerk is directed to prepare a map illustrating the boundaries of each combined precinct, to post the map of the combined precincts in the administrative offices of the school district and to file a copy of the map with the County Auditor. The Clerk shall also file a certified copy of this resolution with said County Auditor.
