Discussion of Preliminary Budget Parameters for 2010-2011 Dr. Braswell presented two key variables in addressing the two revenue streams that are used to prepare the District's budget. The two variables are 1) projected student attendance rates and 2) projected student enrollment. The board also discussed budget issues related to opening two new campuses in the fall of 2010. For the past several years, the district had been growing about 8 percent. This year, the district grew only by 3 percent. Knowing the enrollment would decrease, the budget had been built on a 5 percent enrollment increase. However, instead of the projected 23,384 students, the district had 22,850 students enrolled during the first semester. The district loses \$1.6 million in state funding when the attendance rate decreases by 1 percent. Overall, the district is looking at a \$6 million to \$7 million shortfall in the current year's budget.
