

Ector County ISD Gifted and Talented Services Agreement 2009-2010

Region 18 ESC and Ector County ISD, in working collaboratively to improve student performance in the area of gifted and talented services and to more efficiently manage training provided in this area agree to the following arrangement.

ROLE OF THE ESC

- 1. Provide Ector County ISD with all the services provided in the Gifted and Talented Services Interagency Agreement for the fee of \$10,000. These include:
 - Employ ESC staff to work with the school on an established schedule to conduct training, arrange for outside consultants, and provide planning, staff development, consultant and technical assistance to teachers and administrators.
 - Assist with program evaluation.
 - Assist with revision of long-range plans.
 - Allow participants to attend workshops at reduced rates or with fees waived.
 - Provide meals at student seminars.
 - Special registration discounts for the Interdisciplinary Curriculum/Problem Solving Conference, and the VISION Conference. The discount for the Interdisciplinary Curriculum/Problem Solving Conference includes 30 student and 6 teacher slots at no additional charge.
- 2. Provide Ector County ISD with 400 1-day participant slots in the 2010 VISION Conference. These slots will be assigned to Ector County ISD staff by authorized personnel in charge of Gifted and Talented Services in the district. These slots may be utilized in any combination of 1-day or 2-day attendance as determined by authorized Ector County ISD staff.
- 3. Provide Ector County ISD with 800 1-day participant slots for the 2010 Summer GT Round-Up training provided by Region 18 ESC. These slots will be assigned to Ector County ISD staff by authorized personnel in charge of Gifted and Talented Services in the district. These slots may be utilized for staff attendance as determined by authorized Ector County ISD staff.
- 4. Provide assistance to Ector County ISD staff through the Region 18 ESC system of registration in the proper assigning of personnel and awarding of credits for attending VISION Conference and GT Round-Up.
- 5. Provide these 1200 participant slots for a fee of \$17,000, with no additional fees to be charged for these attendees. Any slots required by Ector County ISD beyond these agreed-upon amounts will be charged at the rate applicable under the Interagency Agreement referenced in Item #1.

ROLE OF ECTOR COUNTY ISD

- 1. Provide Region 18 ESC payment in the total amount of \$27,000.
- 2. Handle all assignment of staff to attend these two functions within the allotted slots.
- 3. Work collaboratively with Region 18 ESC to resolve any questions regarding these slots.
- 4. Communicate any issues and concerns to Region 18 ESC in a timely manner.
