### Background:

School District Procurement Rule R7-2-1053 paragraph A and D states, "A contract may be awarded for a material, service, or construction item without competition if the governing board determines in writing that there is only one source for the required material, service, or construction item. The school district may require the submission of cost or pricing data in connection with an award under this Section. Sole source procurement shall be avoided, except when no reasonable alternative source exists. A copy of the written determination of the basis for the sole source procurements and any costs or pricing data shall be retained in the procurement file by the school district."


Exhibit A contains the Sole Source Vendors for SY25/26. Each of these vendors have been reviewed and the District may continue to use or may need their goods or services in this school year.

Follett School Solutions, Inc. had a name change and is now known as Follett Content Solutions, Inc. per notification and W-9 provided by the company.

Based on the above thorough examination of options and fair and reasonable pricing, this recommendation is in compliance with the School District Procurement Rules. This list remains in effect until updated as needed throughout the school year. The anticipated need for the list is through June 30, 2026.
