4. Manhard PUD Discussion

Steve Luu, Project Manager with Manhard presented on a number of civil engineering topics including:

- PUD and plat process The Village and District are looking at ways to streamline the building permitting process. The Village has suggested utilizing the Planned Unit Development or PUD method. The District will seek advice from legal counsel prior to making a commitment.
- Storm water implications for the Lincoln Hall project are minimal based upon the total amount of

disturbed land. Threshold requirements for disturbed land requiring extensive village review, evaluation, and approval are only for areas of land greater than .50 acres on the campus. The proposed work would include less than .45 acres.

George Demarakis, Project Manager with ARCON Architect's, presented on a number of Lincoln Hall project finishes including:
