**A RESOLUTION OF BRACKETT INDEPENDENT SCHOOL DISTRICT ADOPTING  
THE KINNEY COUNTY MULTI-JURISDICTIONAL HAZARD MITIGATION PLAN,  
AS REQUIRED BY THE FEDERAL DISASTER MITIGATION ACT OF 2000.**

**WHEREAS**, Brackett ISD recognizes the threat that natural hazards pose to people and property within the community; and

**WHEREAS**, undertaking hazard mitigation actions will reduce the potential for harm to people and property from future hazard occurrences; and

**WHEREAS**, the U.S. Congress passed the Disaster Mitigation Act of 2000, emphasizing the need for pre-disaster mitigation of potential hazards; and

**WHEREAS**, the Act made available hazard mitigation grants to state and local governments; and

**WHEREAS**, an adopted Hazard Mitigation Plan is required as a condition of future funding for mitigation projects under the Federal Emergency Management Agency (FEMA) pre- and post-disaster mitigation grant programs; and

**WHEREAS**, Brackett ISD, in coordination with Kinney County and its participating jurisdictions, has fully participated in the FEMA-prescribed mitigation planning process to prepare the Kinney County Multi-Jurisdictional Hazard Mitigation Plan; and

**WHEREAS**, the Texas Division of Emergency Management and FEMA have reviewed the Kinney County Multi-Jurisdictional Hazard Mitigation Plan and approved it contingent upon its formal adoption by participating jurisdictions; and

**WHEREAS**, Brackett ISD desires to comply with the requirements of the Disaster Mitigation Act and to augment its emergency planning and mitigation efforts by formally adopting the plan.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD MEMBERS OF BRACKETT INDEPENDENT SCHOOL DISTRICT:**

1. Brackett ISD Board Members hereby adopt the **Kinney County Multi-Jurisdictional Hazard Mitigation Plan** in its entirety as the official Hazard Mitigation Plan of Brackett ISD.
2. Brackett ISD will pursue the implementation of the recommended actions contained in the plan to the extent practicable.

3. Brackett ISD will continue to participate in the ongoing multi-jurisdictional planning process as established by Kinney County and coordinated by the Kinney County Emergency Management Coordinator.
4. This resolution shall become effective upon its adoption.
