NORTHWEST REGIONAL ESD BOARD MEMBER - ZONE 4

POLICY/SITUATION:

Northwest Regional ESD Board of Directors currently has a vacant position in Zone 4. The Zone 4 position represents the Beaverton and Sunset High School attendance areas as well as Clatskanie, Rainier, Scappoose, St. Helens and Vernonia School Districts.

BACKGROUND INFORMATION:

The previous NWRESD Board Member for Zone 4 was Earl Fisher, who retired at the beginning of 2017. NWRESD worked with PSU on a redistricting study to ensure that they had appropriate zones representing their region. At the completion of that study two applicants filed for the open position representing Zone 4.

NWRESD has divided the four-county region into five zones of approximately equal population. From each of these zones, each school district board has one vote to determine who will represent that zone on the NWRESD Board.

RECOMMENDATION:


It is recommended that the Beaverton School Board discuss and cast their vote for one (1) candidate to fill the vacant position in Zone 4.


