District Legal Counsel Heidi Alder noted there are revised policies ready to present to the Board in upcoming meetings. Two policies briefly discussed today were student dress code, and search and seizure. Our current dress code policy contradicts with school dress codes and has some vagueness. It has been decided to have a single district dress code policy to replace all school dress code policies. It will now include things students can wear and things not aloud at school. Board Member Kelly Larson noted she has met with administrators at PTA meetings regarding school dress codes. It was also noted by Secondary Education Director Brock Mitchell the updated policy will address issues with flags on clothing or using flags draped over clothing.

Policy 5300 Search and Seizure's biggest issue with administrators is conducting vape searches. Opposing solutions discussed could possibly include using hand held detectors. Board input is needed on this difficult policy. Board Member Kelly Larson noted this issue is taking up too much time for our administrators. Board Vice President Jon Ritchie noted there is also fire hazard issues. There will be further discussion on this policy before it is presented to the Board for approval.

Superintendent Butters noted the parent/employee survey was sent out this week regarding school schedules and portrait of a graduate competencies.

HB21 Open and Public Meetings Act Amendment passed in the recent legislative session. All districts are required to have a policy in place beginning July 1, 2023. The Board is asked to provide input for this new policy.

Business Administrator Robert Petersen referred the Board to the memo regarding the purchase of a home and hospital vehicle added to the consent calendar for Board approval today.
