Item Name: CONSIDER APPROVAL OF RFP #06-2023SE DISTRICTWIDE STAFF

DEVELOPMENT AND MATERIALS (SUPPLEMENTAL)

Item Summary: The purpose of RFP #06-2023SE Districtwide Staff Development and Materials (Supplemental) is to add additional vendors. RFP #06-2023SE is a supplemental award to RFP #06-2020LN and RFP #11-2021RL. This type of award is beneficial to the District as it allows campuses and departments a variety of vendors to select from, while ensuring that the District is compliant with purchasing regulations according to TEC 44.031 and EDGAR.

This solicitation requested that vendors supply credentials, high-quality professional content details, evaluation tools, TEKS and/or Industry standard documents and pricing specific to Lamar CISD. In addition, vendors provided their capability of multi-platform delivery options (face-to-face, online, etc.). Pricing specific to Lamar CISD provides benefits for budgeting and overall planning for staff development services and related materials.

Innovative Learning Department staff evaluated submissions based on evaluation criteria specific to quality and the extent to which respondents meet LCISD needs. After evaluation of the businesses who responded, it is recommended that the award be made to all respondents.

This proposal will be awarded as a one-year term contract with two automatic annual renewal options and will expire on August 31, 2025. Contract terms may include a District election to add formal subsequent proposals. Either party may provide a 30-day advance written notice of intent to cancel prior to the annual termination.

Recommendation: Administration recommends that the Board of Trustees consider approval of additional vendors which submitted proposals.
