Dear Senator Estes:

It is my understanding that there is a 20% discount of electrical transmission and distribution charges that Texas State Colleges and Universities take advantage of. This same discount is not available to the school districts of Texas.

Rider SCUD (State Colleges & Universities Discount) is available to any facility of a four-year State university, upper-level institution, Texas State Technical College or college as provided for in Sec. 351 of the Utilities Code. The total of the Transmission and Distribution Charges, System Benefit Fund Charge and Nuclear Decommissioning Charge is reduced by 20%.

If Sec. 351 of the Utilities Code were rewritten to include all Texas school districts, the same 20% discount would yield approximately \$150,000 in savings to Wichita Falls ISD. Assuming the same cost per student savings (\$10), our Texas schools could possibly yield \$40,000,000 in savings annually.

I have enclosed a schedule of utility cost increases that Wichita Falls ISD has been subjected to over the past few years. We have recently been informed that Oncor will be pursuing power factor correction increases in the future. This increase has the potential to cost WFISD \$70,000 which is a 5% increase in total electric costs.
