5. TRUTH IN TAXATION PRESENTATION, Gary Kawlewski

Showing a decrease of 4.02% from the prior year. Levy is based on many state-determined formulas. Received a 1.5% increase on the general education revenue formula allowance along with a 1.5% increase in state Special Education aid. Local property taxes make up about 10% of the general fund revenue. Salaries equal 56% of the General Fund expenditures along with 20.7% equaling employee benefits. Location Equity Revenue was created by the legislature and will take effect with the 2014-15 school year. Goal is to equalize operating referendum by location to metro districts. The net effect for our district is \$1.1 million in total revenue for the general fund but only increases the local levy by \$35,720.
