 - 2. Policy D480.00 Use of School Facilities / 480.00 Use of School Facilities Some price changes have been suggested, and we are looking for Board input before moving forward.
 - **3.** Policy D560.00 Employee Injury: Accident Treatment We are looking for Board input on the addition of requiring staff who are injured to be drug tested if they are seeking medical treatment for an accident at work.
 - 4. Policy 264.00 Mastery Education Policy We have not assigned a number to this concept yet because we are looking for language that will allow the Board to set the parameters for giving grades for mastery rather than just seat time. This could greatly benefit students who have FA or NC grades when they have

- C. New/Amended/Deleted Policies
 - 1. Policy D174.00 Board Agenda (First Reading) The only changes to this policy was wording as to what may be on the agenda and not mandatory.
 - 2. Policy D342.30 Voluntary Drug Testing for Students (Second Reading) There were few clarifications made to this policy. I am recommending it be approved as presented.
 - **3.** Policy D526.10 Sexual Misconduct (Second Reading) This was a new policy from ISBA. If there are no comments, I am recommending it be approved as presented.
 - 4. Policy D544.30 Bereavement Leave (First Reading) Wording has been added to say leave should be used within two weeks of the event.
 - 5. Policy D544.90 Jury Duty (First Reading) Wording was added that if an employee is subpoenaed for any work related event they may use Jury Duty Leave. If an employee is subpoenaed for a personal reason, personal or vacation leave should be used. If all leave is exhausted, the Superintendent may grant one day.
 - Policy D546.00 Staff Travel (Second Reading) This change clarifies when a classified employee (non-salaried) is required to attend an event verses requests to attend an event. I'm recommending this be held for a second reading.
 - Policy 550.00 Substitute Salaries (First Reading) Computer lab assistants have been added for requesting a sub when absent. I am recommending we approve this policy as presented.
 - 8. Policy D580.00 Teacher Responsibility (First Reading) We added wording that states if a teacher is absent, he/she must notify his/ her administrator. Also added was a grade needs to be submitted for students at least once a week. I am recommending we approve this policy as presented.
 - **9.** Policy D596.00 Overtime Classified Personnel (Second Reading) There have been no comments on this policy. I am recommending we approve as presented.
 - **10.** Policy D640.00 District Evaluation Program (First Reading) There have been no comments on this policy. I am recommending we approve as presented.
 - 11. Policy D670.00 Evaluation of Classified Employees (First Reading) Only formatting

changes were made to this policy, therefore I am recommending we approve as presented.
12. Policy D756.00 Payroll Procedures (First Reading) – In the section Late Hires, wording was added in regards to 12 month employees receiving benefits. There have been no comments on this policy. I am recommending we approve as presented.
