LEGISLATIVE UPDATE



- 89th Legislative Session: January 14th June 2nd
- Rep. Dustin Burrows elected Speaker of the House
- Sen. Brandon Creighton appointed chair of Senate Education Committee
- Vouchers
 - Gov. Abbott declared vouchers "emergency item"
 - Senate Bill 2 (Voucher Bill) passed out of committee along party lines at 9-2
 - Fiscal note increasing to nearly \$4 billion by 2030
 - House has not yet filed its voucher bill

FINANCIAL STATISTICS

 Texas House policy analyst Eva Deluna said in June the basic allotment would have to be \$7,500 to account for inflation (\$6,160 since 2019)

- Texas per student funding is \$4,000 below national average according to National Education Association
- Special education weights, safety allotment, and pre-k funding have not increased since 2019, while costs have increased astronomically to provide these services & unfunded mandates
- The state continues to claw back funds from as far back as 2011



BUDGET SHORTFALLS CONTINUE TO PLAGUE TEXAS SCHOOL DISTRICTS

- The Houston Chronicle estimated area school district shortfalls totaled \$857 million for the 2024-25 school year
- Aldine ISD proposes closing 7 schools to battle \$98 million budget deficit
- Houston ISD doubles its 2025 budget deficit forecast to \$250 million –

potentially spurring layoffs

- Spring ISD deficit \$13 million
- Cy-Fair ISD deficit \$138 million
- Midland ISD deficit \$41 million
- Austin ISD deficit \$92 million
- Coppell ISD deficit \$9 million



BUDGET GOALS AND ASSUMPTIONS

- Goals
 - Decrease overall payroll, operating, and program costs
 - Explore employee compensation package & remain competitive
- Assumptions
 - Flat average daily attendance
 - Monitor any new revenue sources and/or unfunded mandates from the legislature

PRIMARY BUDGET DRIVERS

- Revenues
 - Average daily attendance
 - Property values
 - Peripheral revenue sources (often temporary)
- Expenditures
 - Payroll comprises in excess of 80% of total budget

BUDGET ACCOMPLISHMENTS – BUDGETS 2024 & 2025

2024-2025 Budget

Provided 4% general pay increase

Successfully implemented \$13 million in budget reductions, including:

- Closed non-campus positions districtwide
- Adjusted high school and junior school schedules
- Applied staffing ratios to elementaries

2023-2024 Budget

Successfully implemented \$12 million in budget reductions, including:

- Closed nearly 100 positions
- Made reductions without layoffs
- Reduced departmental budgets





2025-26 BUDGET CHALLENGES

- No additional funding since 2019
- Inflation (rose 22% over 5 years)
- Teachers leaving the profession and competition is fierce
- More competition from charter schools
