Alternative Schedule Submission Report Nevada Department of Education 11/18/25

**Description of the Alternative Schedule:** The Nye County School District (NCSD) adopted an alternative four-day instructional week model for its remote rural schools, representing a strategic departure from the traditional five-day schedule.

This shift is authorized under Nevada Revised Statutes (NRS) 388.090, which permits the Superintendent of Public Instruction to approve a school district's application for a program of instruction based on an alternative schedule. Crucially, the alternative schedule must ensure that the total instructional minutes meet the state-mandated requirements.

To maintain this seat time compliance, as determined by multiplying the required minimum daily instructional period by the scheduled number of days (as referenced in NRS 388.090(5)), the District implemented extended daily instructional hours on the four scheduled days.

This policy modification was enacted to proactively address the community's unique logistical needs and serve as a key incentive for attracting and stabilizing the workforce in critically hard-to-staff educational settings.

Effect of the Alternative Schedule: The modified schedule has provided a significant advantage by allowing staff and parents to consolidate non-instructional commitments, such as medical appointments, on the non-school day (Friday). This strategy optimizes instructional continuity by reducing student absences and staff disruption during the school week. The extended daily structure is also credited with promoting a more concentrated and productive instructional period. Crucially, the four-day model aligns directly with the predominant four-day work week of major community employers, thereby supporting enhanced work-life balance and family time.
