# **Meeting Minutes**

July 28, 2015

The Collin County Community College District ("Collin College District) conducted its regular monthly Board of Trustees meeting on July 28, 2015, in the Board Room, Room 139, Collin Higher Education Center, with Chairman J. Robert (Bob) Collins presiding. Trustees in attendance were Ms. Stacy Anne Arias, Mr. Andy Hardin, Mr. Mac Hendricks, Mr. Adrian Rodriguez, Mr. Larry Wainwright and Ms. Nancy Wurzman. Trustees Jenny McCall and Jim Orr were absent. Other attendees included District President H. Neil Matkin, college administrators, faculty, students, staff, and community members.

#### **CALL TO ORDER**

Chairman Collins called the July 28, 2015, meeting of the Board of Trustees of Collin County Community College District to order at 5:30 p.m. The Board met at the Collin Higher Education Center, 3452 Spur 399, McKinney, Texas 75069.

Dr. Matkin presented an update on key bills of interest passed and those not passed by the 84<sup>th</sup> Texas Legislature. Senate and House bills of interest:

- 2. Economic Impact Study Lisa Vasquez, Vice President of Public Relations and College Development

Ms. Vasquez presented a study by EMSI that showed the economic impact of Collin College including:

- Impact on Business Community: College \$96.8 million, Students \$59.1 million, and Alumni \$376.6 million
- Income: \$528.5 million in the Collin College service area
- Return on Investment: Students \$1.2 billion increased earnings over their working lives, Society \$6.1 billion in added state income/\$86.9 million savings (crime, unemployment, and health costs), and Taxpayers \$400.1 million (higher tax receipts) / \$26.2 million savings (burden of justice system, welfare, and unemployment)
- Student Return on Investment: \$1 invested = \$3.70 in lifetime income / 15.6% rate of return
- Society Return on Investment: \$1 invested = \$13.70 in benefits for as long as the student population at Collin College is active in the state workforce
- Taxpayers (state and local) Return on Investment: \$1 invested = \$4.20 in added taxes and public sector savings / 12.7% average annual ROI
- 3. Update on Construction at the Central Park Campus Ben Pogue, President/CEO, Pogue Construction

Mr. Pogue presented slides showing the construction progress at the Central Park Campus. He said much of the exterior work has been completed on the Conference Center and Health Sciences Building. In addition, the existing weight room has been renovated and enlarged. Interior work is ongoing for both new buildings and several photos were displayed. Mr. Pogue said the Conference Center is 90% complete and will be ready in time for the September 3 ribbon-cutting event. The Health Sciences Center is 70% complete. Construction on both buildings is on time and within budget.

Jorge Serano of PBK Architects answered questions regarding issues with the size of pumps, boilers and chillers that were identified by a third party engineer hired by the college. Airflow in the conference center was also an issue. Mr. Serano said PBK was able to provide modifications and incorporate those modifications to minimize disruption to the project. He said everything was still on time for completion.

## **INFORMATION REPORTS**

Julie Bradley, Interim Vice President of Administrative Services and Chief Financial Officer, reported the following:

# Budget Status Report as of 06/30/15

Revenues for the month ending 06/30/15 totaled \$6,598,391 and expenditures \$12,688,435. Expenditures exceeded revenues by \$6,090,044. Year-to-date revenues exceeded expenditures by \$35,054,247.

### Investment Schedule as of 06/30/15

Market value of investments totaled \$255,641,464 for the month ending 06/30/15. Average yield on operating and building fund investments was .22%.

#### PRESIDENT'S AND BOARD ANNOUNCEMENTS

President Matkin announced the following:

- 1. Collin College recently lost two leaders whose vision helped shape the college into the educational institution it is today. Former Board of Trustees Member Tino Trujillo passed away in late June. A founding board member who served the college for almost 30 years, Mr. Trujillo helped establish the college and guide its course until his retirement last year. Dr. David Hammel, who passed away earlier this month, served on the board of trustees from 2004 until 2010 and as a member of the Collin College Foundation board of directors for a decade. Both men will be missed, but the legacy of their service will not be forgotten.
- 2. It is with great sadness that President Matkin told of the passing of Professor Carl Hasler's daughter Rachel after a brief battle with leukemia. Rachel had just turned 26 and was no longer eligible to continue on her father's insurance when her medical treatment began. Dr. Matkin said if anyone would like to help the family, please contact him.
- 3. The National League for Nursing announced that it would once again name Collin College as a NLN Center of Excellence in Nursing Education. The league notified the college earlier this month that it has achieved Center of Excellence honors a second time, with the designation renewal becoming official when announced in Las Vegas at the NLN Education Summit in October. The Centers of Excellence program recognizes schools that have demonstrated a commitment to excellence over a sustained period, distinguishing themselves in nursing education. The college was first named a Center of Excellence in 2011 and the renewal extends through 2019. Congratulations to Vice President Sherry Schumann, Dean of Nursing Donna Hatch, and the nursing faculty, staff, and students on this honor.
- 4. Collin College student Fernando Osornio has received the Congressional Gold Medal from the U.S. House of Representatives. The award was presented to Osornio by U.S. Representative Sam Johnson. This is the highest honor that may be bestowed by the U.S. House of Representatives upon a civilian under the age of 24, other than the Purple Heart. Fernando has also been recognized as one of "DFW's Next Latino Leaders."
- 5. Collin College's Psi Beta chapter has been awarded the 2014-2015 Chapter Excellence Award from the Psi Beta National Honor Society. Fewer than 10 of the nation's Psi Beta chapters earn this distinction each year. Psi Beta is the national honor society in psychology for community and junior colleges. Congratulations to our student members, advisors Joshua Arduengo and Jennifer Brooks, and everyone who helped make the award possible.
- 6. Julie Boganwright, clinical coordinator for the college's respiratory care program has received the "Educator of the Year" award from Texas Society for Respiratory Care.

- 7. Michelle Millen, the program director for Health Information Management, has been elected chair of the Council for Excellence in Education (CEE) of the American Health Information Management Association Foundation (AHIMA). Millen's article, "Patient Engagement: HIM and Education Filling the Gap," will be published in the Journal of the American Health Information Management Association in September 2015.
- 8. The State credentialing exam pass rate for the Collin College Fire Academy graduates is 100 percent. The college's Law Enforcement Academy maintained a perfect pass rate on the Basic Peace Officer certification exam, a 100 percent pass rate for the Telecommunications Operator certification and a 97 percent pass rate on the Correctional Officer certification exam. Thank you to our Fire Academy students, Vice President/Provost Sherry Schumann, Dean Abe Johnson, Fire Academy Director Pat McAuliff, and Police Academy Director Todd Eubanks for their great work.

President Matkin thanked the Board of Trustees and said he was very appreciative of the board members for their work in creating a vision for Collin College and spending much time and energy in planning.

In closing, Dr. Matkin played a video titled "Success in the New Economy." He said Collin College is heavily invested in transfer credit; however, there is a pathway in terms of helping students learn technical skills based on three studies, the last being by Harvard University, and that Collin College is well positioned to do so.

Trustee Wurzman said she had enjoyed working with President Matkin these first few months of his presidency and that she looks forward to the future.

Trustees Hendricks thanked President Matkin and the college employees for their work. He said the college has identified that we need to do some work with advising and that is one of our goals. Dr. Matkin responded that the QEP Team has a good start on advising.

Trustee Rodriguez said it has been great working with President Matkin. He said he hoped everyone had a good summer and that he appreciated all the employees do for the college. He is looking forward to the upcoming year.

Trustee Arias said she appreciated all of Dr. Matkin's efforts and looks forward to the next board retreat to start planning some of the initiatives that the board discussed at its July 27 retreat.
